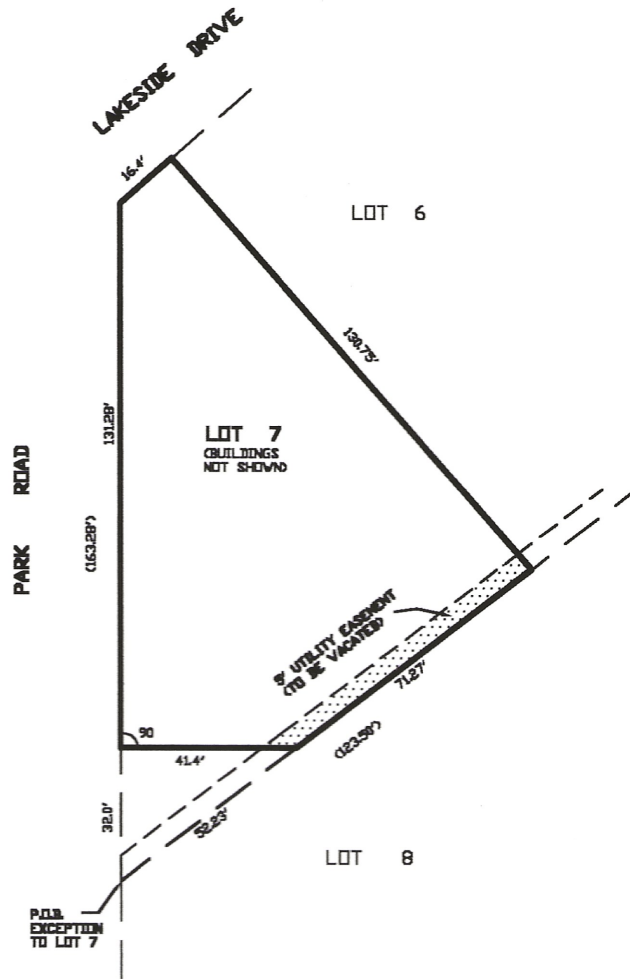


PLAT AMENDMENT



FOR THE SOLE PURPOSE OF VACATING THE EXISTING 5' UTILITY EASEMENT ALONG THE SOUTHEASTERLY LINE OF THAT PART OF LOT 7 DESCRIBED AS FOLLOWS: LOT 7 IN BLOCK 29 IN ARTHUR T. MCINTOSH AND COMPANY'S FOREST LAKE, BEING A SUBDIVISION OF PARTS OF SECTIONS 10 AND 15, TOWNSHIP 43 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED MAY 29, 1987 AS DOCUMENT NO. 487137, IN BOOK 24 OF PLATS, PAGE 49, EXCEPT THAT PART THEREOF DESCRIBED AS FOLLOWS: BEGINNING AT THE INTERSECTION OF THE WEST LINE OF LOT 7 AND THE SOUTHEASTERLY LINE OF LOT 7; THENCE NORTHERLY ALONG THE WEST LINE OF LOT 7 FOR A DISTANCE OF 28 FEET; THENCE EAST ALONG A LINE WHICH MAKES AN ANGLE OF 90 DEGREES WITH THE LAST DESCRIBED LINE, A DISTANCE OF 41.4 FEET MORE OR LESS, TO A POINT IN THE SOUTHEASTERLY LOT LINE OF LOT 7; THENCE SOUTHWESTERLY ALONG THE SOUTHEASTERLY LOT LINE OF LOT 7 A DISTANCE OF 32.25 FEET, MORE OR LESS, TO THE PLACE OF BEGINNING, ALL IN LAKE COUNTY, ILLINOIS.
