COUNTYWIDE SHOOTING HOMICIDE 2023 vs 2024 (to date)

- 8 shooting homicides 2024 vs 11 in 2023 27% Reduction
- Clearance Rate of 88% in 2024 vs 73% in 2023
- 3 Domestic Violence related shooting homicides in 2024 vs 3 in 2023

WAUKEGAN, ZION, NORTH CHICAGO SHOOTING HOMICIDES 2023 vs 2024 (to date)

$\frac{202}{3}\frac{15}{2024} (10 \text{ unit})$

- 4 shooting homicides in 2024 vs 8 in 2023 50% Reduction
- Clearance Rate of 100% in 2024 vs 75% in 2023
- 0 DV related shooting homicides in 2024 vs 3 in 2023
- 18 non-fatal shooting injuries in 2024 vs 22 in 2023 18% Reduction

LAKE COUNTY GUN VIOLENCE: 2022 VS. 2023

- 55% decrease in all homicides countywide between 2022 and 2023
- 47% decrease in GV homicides countywide
- 41% reduction in GV homicides in North Chicago, Zion, Waukegan
- 44% reduction shootings causing non-fatal injuries in NC, WKGN, Zion

HUMAN TRAFFICKING PROSECUTION TASK FORCE

Grant secured in late 2021 as one of six prosecutor offices nationwide to host a collaborative task force in a prosecutor's office Between 2017 and 2021, there was only 1 trafficking case brought by SAO; since 2022, four formal prosecutions have been filed and there are currently 16 active investigations

Consistent communication with federal partners leads to local investigations and vice versa


Aggressively pursuing insurance tenders in cases where Lake County has indemnity rights

Successful in Habdab breach-of-contract case against Mundelein (preparing for arguments in Supreme Court to defend the victory secured in the appellate court



- Total grant revenue \$8.28M
- Since 2020, we have secured 26 grants (15 new to SAO);
- The GVPI and safe storage are now funded at \$4.9M
- Grants fund 33 number of positions out of 155 in the office
- Grants that we are seeking to renew: Human Trafficking, CIU, JJC, LRWC, GVPI
