- Lake County Community Development (CD) administers Lake County AHP funds.
- The Lake County Board approved an initial set of AHP funding recommendations on June 9, 2026.
- CD staff recommends the following recommendations:
 - Reduction of \$6,497 in funding to Community Partners for Affordable Housing (CPAH) for their Mundelein PSH development.
 - Reduction of \$143,503 in funding to Pivotal Development for their Hillside Landing development.
 - Allocation of \$150,000 in AHP funds to Raquan's Haven for the acquisition of an affordable rental property.

Joint resolution accepting the Program Year 2027 (PY2027) Capacity Expansion Grant from the Illinois Department of Human Services, authorizing an emergency appropriation in the amount of \$96,200 for grant administration to increase the capacity of the local homeless crisis response systems, and increasing the authorized headcount of the Community Development department by one full time position.

- This funding combined with other Community Development (CD) funds, will add a Property Engagement Specialist position to CD.
- In addition to personnel costs, funding will be used for contractual services to improve and build dynamic, reliable data systems that can measure real-time changes in homelessness.
- To facilitate this additional work, it is necessary to increase headcount by one full-time employee. The portion of the salary not covered by this grant will be absorbed by existing Community Development funds, including but not limited to HUD Continuum of Care funds.
- If this funding is not renewed and no new resources are found to fund the position, the position will be eliminated.
- The \$96,200 in grant funding has not been previously appropriated because the grant resources were secured after the County's adoption of the Fiscal Year 2026.

Joint resolution to enter into a contract with SCRAM Systems of Greenwood Village, Colorado to provide electronic monitoring services for Lake County Adult Probation in the estimated annual amount of \$400,000.

- There is a need for electronic monitoring services for Lake County Adult Probation.
- The current contract for electronic monitoring is set to expire August 31, 2026.
- Lake County issued a Request for Proposals (RFP) for Electronic Monitoring Services, and sealed proposals were received from 3 vendors.
- Based on the criteria set forth in the RFP, an evaluation committee determined it to be in the best interest of Lake County to award to SCRAM Systems.
- This resolution authorizes a two-year contract with three one-year renewals with SCRAM Systems effective from September 2026 through August 2031.

Joint resolution authorizing a fifty-one-month contract, with West Publishing Corporation, of Eagan, Minnesota for Online Legal, Public Record, Investigative, and Research Services in the amount of \$60,048 for the remainder of Fiscal Year 2026, an amount of \$331,800 starting in Fiscal Year 2027 with 7.5% annual increases thereafter.

- The current contract for online Legal, Public Record, Investigative, and Research services expires July 31, 2026.
- Online legal research provides web-based access to 185 users in various County departments to search legal databases, three patron access terminals in the Law Library and West km provides knowledge management software to 50 users.
- The County departments have selected an upgraded subscription package called CoCounsel Legal that provides AI analytics, deep research and drafting tools that are verifiable and defensible.
- This contract contains a Bridge Period to hold current pricing for the remainder of Fiscal Year 2026, and aligns Year 1 with the County's Fiscal Year.
- The contract authorizes the Purchasing Agent to enter into a fifty-one-month agreement, including the bridge period for a term of September 1, 2026 through November 30, 2030.
- The bridge period will cost the County an amount of \$60,048. The first full year will be \$331,800 with 7.5% annual increases thereafter. The cost will be shared by various Lake County departments based on user counts.
- Purchasing identified a cooperative purchasing contract with West Publishing Corporation, of Eagan, Minnesota, through Minnesota Master Agreement #270079 to procure Online Legal, Public Record, Investigative, and Research Services that

was competitively solicited and awarded.

- Pursuant to Section 33.115 of the Lake County Purchasing Ordinance, Cooperative Purchasing, Lake County may participate in a cooperative purchasing agreement with West Publishing Corporation.

Joint resolution authorizing execution of a contract with Copenhaver Construction, Inc., of Union, Illinois, in the amount of \$230,751 for the Manitou Creek Shoreline Stabilization project at the East Main Pump Station.

- The Lake County Department of Public Works owns and operates the East Main Street Pump Station, which provides sanitary sewer service to residents and businesses within portions of the Villages of Hainesville, Round Lake, Round Lake Beach, Round Lake Heights, and Round Lake Park.
- Along the facility's east streambank, where Manitou Creek flows into Long Lake, erosion has become a significant problem, and without intervention, erosion threatens the stream corridor, the facility's access driveway, and the building itself.
- To halt further degradation and align with Lake County's Manitou Creek Watershed Plan objectives, improvements will be made to include a combination of gabion baskets, stone slope protection, and native vegetation.
- Funding for this project is supported by the Public Works FY26 Capital Improvement Program and also in part by the Lake County Stormwater Management Commission through a \$10,200 Watershed Management Board Grant.
- The County received bids from eight (8) contractors for this work ranging from \$230,751 to \$805,981.90 for the Manitou Creek Shoreline Stabilization project.
- The award of this contract is recommended to the lowest responsive and responsible bidder, Copenhaver Construction, Inc. of Union, Illinois in the amount of \$230,751.
- This resolution authorizes and directs the County Purchasing Agent to execute a contract with Copenhaver Construction, Inc., in the amount of \$230,751.

 - \$300,000 of HOME funds to CPAH for their Lake Forest Senior Cottages development.

Joint resolution authorizing the acceptance of a state fiscal year (SFY) 2027 Juvenile Justice Council (JJC) grant awarded to the Lake County State's Attorney's Office by the Illinois Juvenile Justice Commission (IJJC) through the Illinois Department of Human Services (DHS) to enhance and strengthen the Lake County JJC, which is run by the Lake County State's Attorney's Office, including an emergency appropriation of \$80,000 in grant funds.

- The Lake County Juvenile Justice Council (JJC) is a collaborative effort of many government and private agencies addressing juvenile justice procedures and programs.
- The JJC works to identify initiatives/areas in which attention or enhancement will benefit the County's JJC overall and the individuals involved.
- The Lake County State's Attorney's Office has been awarded a one-year JJC Grant in the amount of \$80,000 from the Illinois Juvenile Justice Commission (IJJC) through the Illinois Department of Human Services (IDHS).
- The grant term is July 1, 2026 through June 30, 2027.
- The Lake County State's Attorney's Office will use the funds to enhance and strengthen the JJC through annual training, outreach and focusing on programs that are proactive in preventing delinquency.
- Grant program funding in the amount of \$80,000 will support the creation and

purchase of preventative/proactive printed materials and giveaways, webpage/website designer, attendance at the annual Juvenile Justice Council Conference, and two part-time, contracted positions - a JJC Coordinator and a Racial and Ethnic Disparity Reduction Coordinator.

- The source of funding for this JJC project is 100 percent grant funds; no matching funding is required.

- In 1971, the Lake County Division of Transportation acquired right-of-way at the northeast corner of the intersection of Washington Street and Illinois Route 21 for corridor improvements along Washington Street.
- There is a 3,872 square feet (0.0889 acres) portion of this right-of-way that is not needed for current or future transportation purposes.
- The adjacent property owner is willing to pay \$21,500 for the property, which is fair

market value based on a property valuation.

- The County Board may authorize the vacation of county highway right-of-way in accordance with State statute.

Joint resolution authorizing an agreement with Election Systems & Software, Omaha, Nebraska for Voting Tabulation Systems and related Services for the Lake County Clerk's Office in an amount of \$2,405,943 for the first year, and an annual amount of \$212,660 thereafter.

- Since 2001, the Lake County Clerk's Office has been using Election Systems & Software. The system encompasses the tabulation process, ballot creation, and accessible voting options for Lake County elections.
- Pursuant to Chapter 33.066 Bid Exemption of the Lake County Purchasing Ordinance, the Purchasing Agent engaged an ad hoc committee that approved a bid exemption on the basis of an existing long standing successful relationship, and the knowledge gained through this relationship adds value integral to the services provided.
- This agreement provides for software maintenance fees for a five-year period.
- This resolution authorizes a five-year contract with Election Systems & Software, Omaha, Nebraska, for an amount of \$2,405,943 for the first year, and an annual amount of \$212,660 thereafter.
