CHAIR'S REMARKS

Passage of Lake County Bills: Really want to thank the Legislative Committee, led by Member Wasik, for their hard work and advocacy for several Lake County sponsored bills. I want to highlight two bills, HB 1067 and SB 1997.

House Bill 1067 has passed both the House and the Senate and will be sent to Governor Pritzker's office for his signature. This bill allows for a larger potential hiring pool for the position of Superintendent of Public Works by allowing counties to consider years of experience, rather than a particular degree or certification, to manage the Public Works department. REMOVE UNNECESSARY JOB REQUIREMENTS This is something that municipalities already enjoy, and I firmly believe that on the job experience is an important indicator of performance. Overall, when we remove unnecessary barriers to job advancement, we level the playing field and allow people more opportunities to grow. This is a philosophy that we can implement at every level, and we will be following in the footsteps of successful companies and states across the country, that are reevaluating their hiring criteria by analyzing the job itself. I know there are more opportunities in Lake— and I look forward to hearing about those positions where we can provide greater opportunities for our employees.

Senate Bill 1997 is a bill put forward by Member Frank that would allow counties to establish minimum requirements for new building design and construction to lessen the risks caused by new building design and construction to wildlife and sensitive habitats. As we heard from Member Maine, Lake County, especially along the lakefront, provides critical flyway for migratory birds. Bird strikes in the entire Chicagoland area kill thousands of birds every year, and I really appreciate Member Frank's forward-thinking on fighting for this bill. I believe he said in committee that it took five years for this to come to fruition. Lastly, I want to highlight a bill that was a newer addition to our legislative agenda but one that combats an issue that I first learned about when I was new to the LC Board, and that is SB 1883, which makes it unlawful for any person to allow any member of the public to come into direct contact with a bear or nonhuman primate. While this one may seem odd, it's actually important, because it essentially puts the traveling circuses and roadside attractions that are cruel to animals. The one that I think about is the one that has been at the LC Fair for several years, where capuchin monkeys are collared and chained to the backs of dogs, which run in circles for hours every day in the hot sun for entertainment purposes.

I really want to thank each of you, my colleagues, for your thoughtful consideration of the bills and ideas we put forth, not just in legislation but in our own ordinances too. I believe we are making Lake County a better place to live and do work, and I appreciate your dedication and commitment to ensuring a better future for our children.

Coronavirus (COVID-19) Updates

As of May 4, 2023, Lake County has had over 179,270 confirmed COVID-19 cases and 1,544 deaths throughout the pandemic. Lake County's recovery rate is 99.2%.

Lake County remains at a "low" community level along with most counties in Illinois. With a 28.71 case rate per 100,000, this is the lowest Lake County has seen in months.

When a county is at a "low" community level, the CDC recommends:

Wearing a mask if you have symptoms, test positive, or have been exposed to someone with COVID-19 and when on public transportation.

Staying up to date with COVID-19 vaccines.

Getting tested if you have symptoms.

Talking to your healthcare provider if you are at higher risk of severe illness and in need of taking additional precautions.

On May 1, 2023, the Lake County Health Department and Community Health Center made masks optional for employees, clients, and visitors.

Masks will still be required for patients seeking medical care for respiratory symptoms and those presenting with respiratory symptoms (including viral rash).

Additionally, social distancing will no longer be required and all waiting areas may return to full capacity.

Coronavirus (COVID-19) Vaccine Updates

The bivalent COVID-19 booster continues to be available throughout Lake County and is recommended for everyone ages 5 and up who are fully vaccinated.

As of Apr 26, 2023:

Over 270 million people, or 81.4% of the US population, have received at least one dose of a COVID-19 vaccine.

Over 230 million people, or 69.5% of the US population, are fully vaccinated.

Over 56 million people, or 16.9% of the US population, have received the updated bivalent booster dose.

Nearly 87.6 % of all eligible Lake County residents, ages 5 years and older are fully vaccinated.

May is Mental Health Awareness Month

Clean hands are crucial to keeping patients and health workers safe.

Clean hands save lives and reduce costs. Lack of hand hygiene can cause infections, avoidable treatment, and in some cases, death.

You can practice good hand hygiene by regularly washing your hands with soap and water for at least 20 seconds or using alcohol-based hand sanitizer.

Tick Prevention

Tick exposure can occur year-round, but ticks are most active during warmer months, typically from April to September.

Ticks live in grassy or wooded areas and can carry diseases, such as Lyme disease, which are harmful to humans and animals when bitten. It is important to know how to prevent, check for, and remove ticks on yourself, your family, and pets.

To raise awareness about the importance of tick prevention, the Lake County Health Department asked residents to submit photos of their pets to become one of the tick prevention mascots for 2023,

The Health Department received over 600 submissions from community members, and the selections started being revealed on social media in the beginning of May.

Lake County Partners Update.

LCP HOSTS RECORD-BREAKING CROWD AT BIG EVENT

Lake County Partners' Big Event once again brought together 500+ business and civic leaders for a program that touted recent economic growth and celebrated LCP's 25th anniversary. As measured by jobs and investment, the last four years have been one of the best runs in Lake County's history. Since 2019, Lake County Partners has been directly involved in projects that have resulted in 4,155 new jobs, 4,677 retained jobs and \$807 million in direct investment.

LCP is currently nurturing 22 new projects, with six wins already under its belt this year. In the last four months alone, LCP has welcomed a new PR company, food manufacturer, vitamin supplements manufacturer, frozen pizza manufacturer, food equipment manufacturer and an affordable senior housing project, which has resulted in over \$190 million in new capital expenditure, 666,000 sq. ft. of new and reactivated space, 493 new jobs and 450 retained jobs. The back half of this year is lining up to be similarly successful.

Highlighting the surge in local food manufacturing, Henry Broch Foods was presented with the 2023 Community Investment Award at the Big Event. The company is expanding its existing Waukegan headquarters by adding 160,000 sq. ft. of new production, robotic warehouse and distribution space. The project will retain 400 jobs and create 150 new jobs, with a capital investment of nearly \$40 million.

CTE FUELS BUSINESS GROWTH

Lake County has emerged as a leader in high school-level Career and Technical Education (CTE), putting local institutions at the forefront of education in Illinois and the nation. Not only is the Lake County Tech Campus the largest CTE center in the state, but LCP's survey of 18 high schools found overwhelming support for CTE, with 14,244 students participating across the fields of manufacturing, healthcare and information technology. Manufacturing makes up the largest percentage of the cohort, with over 8,000 students participating.

Participating educators anticipate that the enrollment numbers will continue to climb as more robust course selections are created and exciting new opportunities emerge in fields like sports medicine, agriculture, video/animation and robotics.
