- The revised Water Supply Agreement incorporates language to address Village concerns including an acknowledgment that the County shall incorporate and collect the Village connection fees in a County subordinate revenue bond issuance, and that the Village will not owe or be responsible for any of the costs of such a subordinate bond issuance.
- Resolution approves the attached Water Supply and Sales Agreement with Aqua Illinois and Village of Hawthorn Woods and directs staff to send approved copies to the Aqua Illinois and the Village of Hawthorn Woods to request their approval of the Water Supply and Sales Agreement.

 - There is a need to maintain an inventory of ice control chemical to accommodate the Lake County building complex in downtown Waukegan.
 - In accordance with Article 6-103 of the Lake County Purchasing Ordinance, the Facilities Manager certified an emergency condition.
 - The Facilities Management Division solicited quotations from six (6) suppliers.
 - Cryotech Deicing Technology, Fort Madison, IA provided the lowest responsive quotation for 400 bags of Calcium Magnesium Acetate in the amount of \$26,193.
 - This is to ratify an Emergency Procurement authorized by the Facilities Manager with Cryotech Deicing Technology, Fort Madison, IA in the amount of \$26,193.
 - The purchase was charged to account # 101-1220030-61040-031-000-000-00000.
- 31. 08-0945 Resolution authorizing a one-year contract, with renewals with Iskalis American Floor Show of Gurnee, IL for carpeting and tile (vct) for Lake County Facilities in the estimated amount of \$120,900.

 - Lake County desires to enter into a two-year contract, with renewals with Alpha Building Maintenance Service, Inc., of Homer Glen, IL for Janitorial Services.
 - Bids were called for the combined Janitorial Services requirements of the Lake County Health Department and Community Health Center (Group 1), and various Lake County facilities (Group 2).
 - Invitations for bid were extended to twenty-eight (28) vendors; sealed bids were received from ten (10) vendors. One non-responsive bid was received.
 - Alpha Building Maintenance Service, Inc., of Homer Glen, IL is the lowest responsive and responsible bidder for Group 2 in the amount of \$145,398 per year charging the costs to various Lake County accounts.
 - Other bids received ranged in price from \$164,415 to \$372,064.92.
- 33. 08-0978 Resolution authorizing a one-year contract, with renewals with Ground Up Snow and Ice Control of Grayslake, IL for Snow Plowing and Removal Services for various Lake County locations in the estimated amount of \$53,095.
 - Lake County desires to enter into a one-year contract with Ground Up Snow and Ice Control of Grayslake, IL for Snow Plowing and Removal Services for the Mundelein, Round Lake Beach and Park City Branch Courts, Children's Advocacy Center and Solid Waste Agency of Lake County (SWALCO).
 - Invitations for bid were extended to nine (9) vendors; sealed bids were received from five (5) vendors.
 - Ground Up Snow and Ice Control of Grayslake, IL is the lowest responsive and responsible bidder in the estimated amount of \$53,095 charged to various Lake County accounts.
 - Other bids received ranged in price from \$54,290 to \$85,625.

 - Lake County desires to enter into a contract for Classification Review Services.
 - Lake County extended requests to twelve (12) potential vendors and nine (9) proposals were received.
 - An Evaluation Committee comprised of representatives from the Health Department, Human Resources, Judicial Operations and Finance and Administrative Services reviewed all proposals and held interviews with the top four (4) ranked firms.
 - Management Advisory Group, Inc., Woodbridge, VA is recommended as the firm that best meets the needs of the County based on RFP evaluation criteria.
 - This contract will cost the County an amount not to exceed \$58,250.
- 35. 08-0956 Resolution authorizing an agreement with the Board of Trustees of the University of Illinois for Orthorectification Services of historical aerial photography in an amount not to exceed \$51,988.

- There is a need to obtain Orthorectification Services of historical aerial photography of Lake County for the GIS Division of the Information Technology Department.
- Orthorectification is a process by which existing scanned historical aerial
 photography is referenced so that it will overlay existing Lake County GIS data,
 allowing GIS users to measure distances and easily compare to other years of
 photography.
- Historical aerial photography is used by the Chief County Assessment Office, Planning Building and Development, Stormwater Management and the Health Department in day-to-day operations and the Lake County Forest Preserve District and other conservation-oriented groups use it as part of their planning process to restore land to a natural state.
- The Illinois State Geological Survey Division of the University of Illinois has proposed Orthorectification Services of scanned historical aerial photography from the years 1961, 1980-81, 1984-86, and 1993 and there exists a long standing and successful relationship with the Illinois State Geological Survey Division who has provided similar professional services for Lake County.
- The Purchasing Agent convened an ad hoc review group that approved bid exemption on the basis that there exists a long standing, successful relationship for professional services, and the knowledge gained through this relationship adds value integral to the services provided for these services.
- The contract will cost \$51,988 charged to account 101-1300050-71730-000-000-000-000-00000.
- 36. 08-0934 Resolution granting a utility easement to North Shore Gas on the Lake County Health Departments Grand Avenue Campus.
 - Lake County Health Department and Community Health Center is constructing new facilities on the Grand Avenue campus in Waukegan.
 - This project requires the relocation and replacement of various underground public utility services.
 - The natural gas service provided by the North Shore Gas Company must be moved as a result of building construction.
 - The Lake County Board needs to grant the utility easement because the County of Lake is the property owner.

Health and Community Services Committee:

- 37. 08-0843 Resolution to enter into an agreement with Integrity Developers, Inc. Incumbent Worker Training Grant.
 - In response to outreach efforts, Integrity Developers, Inc. expressed interest in the incumbent worker training program. Integrity Developers, Inc. line of business involves rehabs & remodeling, additions & build outs, design build, project management, concrete & asphalt paving, new homes, retail & commercial build; employs three (3) employees; located in Waukegan, and has been in business for two (2) years.

- After consultation with Integrity Developers, Inc. a training solutions curriculum was prepared to train three (3) Integrity Developers, Inc. employees for a total of 32 training hours per person so as to enhance their management of projects as it relates to cost estimating, bidding, document and data management.
- The state policy requires that an employer with 50 or less employees provide 10% of the cost of the training. The policy also states that employee wages & fringes can be used to off-set the employer match without employer having to pay additional funds out of pocket.
- The total cost of training is \$5,335. Lake County Workforce Development will reimburse \$5,335 and the company will provide employee hourly wages of an additional \$533.50 to show for their portion of the match. Cost per employee is \$1,778.33 for 32 hours training for each employee.
- 38. 08-0844 Resolution to enter into an agreement with Vapor Bus International Incumbent Worker Training Grant.
 - In response to outreach efforts, Vapor Bus International, expressed interest in the incumbent worker training program. Vapor Bus Internationals line of business involves the designing and building of door systems for public transit use and designing and manufacturing a wide variety of safety interlocks and sensing systems to ensure passenger safety; employs 194 employees; is located in Buffalo Grove, and has been in business for 105 years.
 - After consultation with Vapor Bus International, a training solutions curriculum
 was prepared to train 40 employees in blueprint reading and 70 employees in
 basic technology skill building, a total of 110 employees so as to increase the
 technical competency, increase production, and advance the company and
 employees into the 21st century.
 - The state policy requires that an employer with 100 or more employees provide 50% of the cost of the training. The policy also states that employee wages & fringes can be used to off-set the employer match without employer having to pay additional funds out of pocket. The total cost of training is \$8,600. Lake County Workforce Development will reimburse \$8,600 and the company will provide employee hourly wages of an additional \$4,300 to show for their portion of the match. Cost per employee is \$78.18 for 6 hours training for each employee.
- 39. 08-0884 Resolution to enter into an agreement with Complete Orthopaedic Care, LLC Incumbent Worker Training Grant.
 - In response to outreach efforts, Complete Orthopaedic Care, LLC expressed interest in the incumbent worker training program. Complete Orthopaedic Care, LL. specializes in Medical Services and Surgical Services for children and adults including arthroscopic surgery, carpal tunnel treatment, shoulder, hip and knee replacement, knee and ankle injuries, sports medicine, tendon and ligament repair, just to name a few of the specialties; employs 37 employees; is located in Lincolnshire, and has been in business for 26 years.
 - After consultation with Complete Orthopaedic Care, LLC a training solutions curriculum was prepared to train 24 Complete Orthopaedic Care, LLC employees for a total of 155 training hours per person so as to train employees on automated

- transcription and clinical workflow management systems to become more efficient in reporting, accessing patient records, and gathering and analyzing data which results to increased productivity, remaining competitive, and skills upgrades and wage increases for employees.
- The state policy requires that an employer with 50 or less employees provide 10% of the cost of the training. The policy also states that employee wages & fringes can be used to off-set the employer match without employer having to pay additional funds out of pocket. The total cost of training is \$44,600. Lake County Workforce Development will reimburse \$44,600 and the company will provide employee hourly wages of an additional \$4,460 to show for their portion of the match. Cost per employee is \$1,858.33 for 155 hours training for each employee.
- 40. 08-0870 Joint Resolution approving and authorizing execution of an Economic Development Incentive Agreement between Gregory Gesualdo and Gregory Chrysler Jeep, Inc. and Lake County.
 - In 2005, the County and Fair Oaks Land, LLC entered into an Economic Development Incentive Agreement providing for the abatement of sales taxes for a period not to exceed ten (10) years or until \$1,250,000 in Economic Incentive Payments have been paid by the County.
 - The agreement also contained rights enabling Fair Oaks Land, LLC to transfer its interest in the Agreement to other franchised automobile dealerships.
 - Fair Oaks Land, LLC sold the property to two auto dealerships.
 - The incentive payments are proposed to be split evenly between the owners of the two parcels.
 - Gregory Gesualdo and Gregory Chrysler Jeep, Inc., are now the owner and operator of the 4.0 acres, and shall be eligible to receive a maximum abatement of sales taxes of \$625,000 over a ten (10) year period.
- 41. 08-0871 Joint Resolution approving and authorizing execution of an Economic Development Incentive Agreement between 18834 Grand Building Corp. and Lakeside Ford LLC d/b/a Gurnee Ford-Lincoln-Mercury and Lake County.
 - In 2005, the County and Fair Oaks Land, LLC entered into an Economic Development Incentive Agreement providing for the abatement of sales taxes for a period not to exceed ten (10) years or until \$1,250,000 in Economic Incentive Payments have been paid by the County.
 - The agreement also contained rights enabling Fair Oaks Land, LLC to transfer its interest in the Agreement to other franchised automobile dealerships.
 - Fair Oaks Land, LLC sold the property to two auto dealerships.
 - The incentive payments are proposed to be split evenly between the owners of the two parcels.
 - 18834 Grand Building Corp is now the owner and operator of the 4.5 acres, and will operate Lakeside Ford LLC d/b/a Gurnee Ford-Lincoln-Mercury; and shall be eligible to receive a maximum abatement of sales taxes of \$625,000 over a ten (10) year period.

Law and Judicial Committee:

- 42. 08-0885 Joint Resolution authorizing an agreement with Century Automatic Sprinkler Co., Inc. in the estimated amount of \$79,446 to upgrade the existing Automatic Sprinkler System in the Babcox Justice Center, and with Fox Valley Fire and Safety Company in the amount of \$45,600 to replace the Wet Chemical Fire Suppression System in the kitchen.
 - Bids were requested for three (3) related projects including: No. 1) upgrading the existing Automatic Sprinkler System in the Babcox Justice Center, No. 2) replacing the Wet Chemical Fire Suppression System in the kitchen, and No. 3) replacing existing sprinkler heads in the kitchen.
 - Bids were extended to the eleven (11) firms and four (4) vendors responded.
 - Century Automatic Sprinkler Co., Inc, Gurnee, Il is the lowest responsive and responsible bidder for No. 1) the upgrade of the existing Automatic Sprinkler System for \$76,386 and for No. 3) replacement of existing sprinkler heads in the kitchen for \$3,060 for a total contract amount not to exceed \$79,446.
 - Fox Valley Fire and Safety Company, Elgin IL is the lowest responsive and responsible bidder for No. 2) replacement of the Wet Chemical Fire Suppression System for \$45,600.
 - One non-responsive bid was received from Century Automatic Sprinkler Co., Inc, Gurnee, IL for the Wet Chemical Fire Suppression System.
- 43. 08-0886 Joint Resolution authorizing an agreement for the purchase of consulting services with URL Integration to allocate the 2008 COPS grant for the Integrated Justice Project in an amount not-to-exceed \$448,943.55.
 - In October, 2008, the Lake County Board approved and accepted the 2008 COPS
 Grant to implement key Sentencing Order exchanges consist of Court
 Supervision, Felony, Misdemeanor, and Probation and Information exchanges
 consisting of Bench Warrant, Warrant Quash, Remand, Release, Felony Review
 Report, Search Warrant, Summons, Subpoena, Work Release Violation, Court
 Date, and Offender Release.
 - Lake County has a long standing and successful relationship with URL Integration who has provided professional services for the integration of justice agencies.
 - The Purchasing Agent previously convened an ad hoc group that approved bid exemption on the basis of the long standing, successful relationship. The knowledge gained through this relationship adds value integral to the services provided.
 - This authorizes a contract with URL Integration to expend the COPS Grant funds on components of the Integrated Justice project in an amount not to exceed \$448,943.55.
- 44. 08-0936 Joint Resolution authorizing a contract between Lake County and its Emergency Telephone System Board (ETSB) and the Wauconda Fire Department, Inc in the amount not to exceed \$27,000 to lease office space for the daily operations of the ETSB and its staff.

- The ETSB is unable to continue to occupy their current space in the Wauconda Police Department and needs to contract for new office space for their equipment and staff members.
- This Resolution authorizes a five (5) year lease (with two (2), five-year extensions) for 1,000 square feet in the Wauconda Fire Department building.
- The County is authorized to lease real property for a public use for up to twenty years and the ETSB is authorized to use its surcharge funds for construction on facilities.
- In exchange for use of the space, including the initial term and any extensions, the County, using ETSB funds, will reimburse Wauconda Fire Departments costs to remodel the space to accommodate the ETSBs need for office space including plumbing, electrical and storage considerations.
- Cost of the remodeling will not exceed \$27,000 and will be overseen by the Wauconda Fire Department according to drawings attached to Lease Agreement.
- The remodeling contract will be competitively bid and adhere to any and all state, federal and local laws, regulations and ordinances.
- Wauconda Police Department needs to use the space, currently occupied by the ETSB, for its Police Investigations Unit as soon as possible and the remodeling of the ETSBs new space will require several weeks; therefore approval of this Lease is critical.

Public Works and Transportation Committee:

- 45. 08-0903 Joint Resolution confirming an emergency contract with Conserve FS, Woodstock, Illinois, for the supply of 15,500 tons of ice control salt at the unit price of \$137.32 per ton; and designated as Section 08-00000-00-GM; and rescinds the emergency contracts for (1) the undelivered quantity of ice control salt estimated to be 17,115 tons at the unit price of \$146.84 per ton and (2) the unconfirmed quantity of 5,000 tons at the unit price of \$130 per ton.
 - 2008 Ice Control Salt: Confirming Emergency Contract
 - The County Engineer certified an emergency procurement for salt for the 2008-2009 winter season was necessary and thereafter procured, by contract quotes, supplies from three salt suppliers to fill the 36,000 ton need (with approximately going to townships).
 - The first vendor is: Peterson Salt and Water Treatment, Minnetonka, Minnesota for the supply of 8,000 tons at the unit price of \$130.00 per ton.
 - The second vendor is Mid Atlantic Salt, LLC., Lydora, Pennsylvania for the supply of 19,000 tons at unit the price of \$146.84 per ton and
 - The third vendor is Central Salt, Elgin, Illinois, for the supply of 4,000 tons at the unit price of \$129.10 per ton.
 - The first vendor is unable to confirm supplying a portion of their order, 5,000 tons at the unit price of \$130.00 per ton.
 - The second vendor is unable to supply salt that meets the specified quality requirements and both parties have mutually agreed that this emergency contract be rescinded.

- Lake County has located an adequate alternate source for the supply of ice control salt of the unit price of \$137.32 per ton.

 - <u>Lake County PASSAGE</u>, Wireless Communication Hub #1: Village of Mundelein Agreement.
 - Wireless communication technology has advanced enough to meet the communication needs of Lake County PASSAGE in certain limited areas, as part of the Phase II contract.
 - Such an area is in various parts of central Lake County including the Village of Mundelein.
 - This agreement provides for the installation of communications antennae on the Village of Mundelein water tower situated adjacent to Winchester Road designated as Wireless Communication Hub #1.
- 55. 08-0941 Joint Resolution authorizing the execution of an agreement between Lake County and PACE for the inclusion of a transit signal priority system in the countys traffic signal interconnection project along Washington Street in the City of Waukegan and designated as Section 04-00272-00-TL.
 - Washington Street PASSAGE Interconnect (Sheridan Rd to Teske Blvd); Transit Signal Priority System: PACE Agreement
 - Lake County is installing an interconnected traffic control signal system along Washington St in the City of Waukegan between Sheridan Rd and Teske Blvd as part of Lake County PASSAGE.
 - Lake County has secured federal CMAQ funds for this improvement, including the installation of a transit signal priority system (TSP).
 - PACE desires to utilize the TSP system to facilitate the delivery of their bus services in the Washington St corridor.
 - The TSP system allows the PACE bus operator to electronically hold or extend the green time on Washington St.

- The current agreement expires December 31, 2008.
- Lake County and Commonwealth Edison Company mutually desire to extend the conditions of said easement as it relates to the right of way but as yet have not been able to finalize the terms of such extension.
- This resolution authorizes an agreement to extend said easement to December 31, 2009.
- 57. 08-0944 Joint Resolution appropriating \$120,000 of Matching Tax funds for professional engineering services and emergency contract construction repairs to the failed retaining wall along Fairfield Road north of IL Route 60 and designated as Section 09-00000-03-BG.
 - Fairfield Road (north of IL Rte 60) Failed Retaining Wall; Emergency Design and Contract Construction Repairs: Appropriation
 - A segmental concrete block retaining wall on the east side of Fairfield Road north of Rte. 60 is failing.
 - The County Engineer declared an emergency procurement situation existed because of the eminent danger of accompanying failure to the highway road surface and lack of time to design, bid and construct before the winter season.
 - This resolution authorizes the necessary professional engineering services, the emergency contract and construction repairs in the appropriation of \$120,000 of Matching Tax funds for these services.

 - Other bids received ranged in price from \$78,622 to \$113,345.
- 59. 08-0952 Joint Resolution authorizing the execution of an agreement between Lake County and the City of Highland Park for the improvement to certain traffic control signals under the jurisdiction of the City of Highland Park, via an initial and later CMAQ grants awarded to the County by the State of Illinois.  - <u>Lake County PASSAGE</u>, <u>Traffic Signal Interconnect</u>: <u>City of Highland Park Agreement</u>

PLANNING, BUILDING AND ZONING COMMITTEE:

- 60. 08-0712 Resolution on Zoning Case No. 3739, which consists of the Petition of Michael Corbett, record Owner, and Jack and Margaret Buttacavoli, record owners and the contract purchasers, which seeks rezoning from the Residential-2 zoned to the Limited Commercial zone.
 - The addresses of the two properties are 34039 and 34047 N. Hainesville Road, Round Lake Park, Avon twp. They are located approximately 135 feet north of the intersection of Hainesville Road and Washington Street. The area of both parcels is 0.35 acres.
 - The applicants own the adjoining parcel to the south which has a sign business and restaurant. The applicants intend to relocate the sign business into the existing house on one of the properties (address 34039) and create the parking on the other.
 - The County's Framework Plan is Residential (0.25 1 acre lot density) which reflects the former single-family use on the property of the rezoning request.
 - The ZBA recommends approval (5-0-1). Staff recommends approval. Board Member Leafblad and several residents of the Highland Lake neighborhood attended the ZBA hearing to oppose the requested rezoning.
 - This item was postponed from the October 7, 2008 PB&Z Committee meeting to allow more time for the applicant and staff to work on issues pertaining to the site plan.
 - The Planning, Building and Zoning Committee voted 6-0 to recommend in favor of the rezoning.

Member Newton moved, seconded by Member Gravenhorst, to approve the Resolution. The Chair called for a Voice Vote on the motion. The motion carried.

- 61. 08-0823 Ordinance adopting the North Branch Chicago River Watershed Plan prepared by the Lake County Stormwater Management Commission (SMC) as an Amendment to the Lake County Comprehensive Stormwater Management Plan.
 - Once adopted, the North Branch Chicago River Watershed Management Plan will become an amendment to the Lake County Comprehensive Stormwater Management Plan adopted by county ordinance in 1990 and updated in 2002.
 - The North Branch Chicago River watershed includes portions of fourteen (14) municipalities, seven (7) townships, eight (8) county board districts and four (4) drainage districts in Lake County.
 - The Plan was developed to provide a blueprint for reducing flood damages, improving water quality and protecting natural resources in the watershed. The Plan assists private citizens and local, State, and Federal governments to better manage the water resources of this watershed in a cost-effective and environmentally sound manner.
 - The Plan was developed through a cooperative effort between the Lake County Stormwater Management Commission and representatives of North Branch watershed stakeholders. Numerous entities, ranging from homeowners associations to municipal governments and county agencies, attended regular meetings and provided input during the planning process.
 - The required public hearing and 60-day comment period for the Illinois Department of Natural Resources, the Chicago Metropolitan Agency for Planning, adjoining counties and the general public has been met.
 - The Lake County Stormwater Management Commission unanimously approved the North Branch Chicago Watershed Plan on September 4, 2008.

Member Newton moved, seconded by Member Bassi, to approve the Ordinance. The Chair called for a Voice Vote on the motion. The motion carried.

- 62. 08-0908 Ordinance adopting amendments to the Lake County Watershed Development Ordinance.
 - In response to widespread cases of property damage due to flooding in the Fox River watershed, SMC proposes an amendment to the Watershed Development Ordinance that allows the repair of properties with up to four (4) inches of topsoil (top dressing) after a documented flood event with evidence of subsidence on the property.
 - SMCs Technical Advisory Committee approved this amendment on August 21st. A 60-day public comment period was held, with revisions based on two (2) comments. SMC approved the amendment on November 6th.
 - SMC requests Planning, Building and Zoning Committee and County Board approval.

Member Newton moved, seconded by Member Carter, to approve the Ordinance. The Chair called for a Voice Vote on the motion. The motion carried.

- 63. 08-0827 Joint Resolution authorizing the States Attorney of Lake County to institute legal action against certain named properties for the demolition of dangerous and unsafe or uncompleted and abandoned structures on said properties.
 - CDH 22-08—Section 11, Township 46 North, Range 9, PIN 01-11-310-015, commonly known as 42326 N. Willow Street, Antioch, IL (an unsafe, dilapidated boathouse.)
 - EAB 24-08—Section 18, Township 45 North, Range 10, PIN 06-18-112-007, commonly known as 24779 W. Clinton Avenue, Round Lake, IL (an unsafe, fire-damaged residential structure.)
 - KLR 27-08—Section 14, Township 45 North, Range 9, PIN 05-14-309-001, commonly known as 6901 W. Longwood Drive, Ingleside, IL (a dangerous, unsafe, vacant and open residential structure.)

Member Spielman reported on Representative Melissa Bean's visit to Midlakes Medical Clinic, and on the Environmental Health Division hosting a delegation from China regarding food safety.

- 80. 08-0839 Emergency Appropriation in the amount of \$1,859,488 in the FY2008 Health Department Budget.
 - The Health Department has been awarded six (6) new grants and has also received increased revenues from Behavioral Health, Community Health, Environmental Health and Primary Care Service Areas.
 - These funds have not been previously appropriated because they were awarded after the adoption of the FY2008 budget.
 - The new grants and additional revenue for the Health Department totals \$1,859,488 and a complete list of the sources of these funds is included in the resolution.

Member Carlson moved, seconded by Member Powers, to approve the Resolution. The Chair called for a Roll Call Vote on the motion. The motion carried with the following vote: Aye 21, Nay 0.

- 81. 08-0833 Amendment to the Lake County Board of Health Ordinance Article XIII (Fees Schedule).
 - Certain Lake County Board of Health Ordinances establish requirements for permits or licenses that must be renewed on an annual basis.
 - Most annual permits and licenses must be renewed by January 1st (June 1st for vending machines), and Lake County Board of Health Ordinance Article XIII (Environmental Health Fees) applies late fees to annually renewed permits or licenses not paid when due as follows:
 - 25% after February 15 (July 15 for Vending Machine Permits)
 - ♦ 50% after March 15 (August 15 for Vending Machine Permits)
 - ♦ 100% after April 15 (September 15 for Vending Machine Permits)
 - This provision of payment options extending 3 months beyond the permit/license renewal deadline establishes a circumstance that is directly contrary to the provisions of those Ordinances establishing the permit/license requirement. Lake County Board of Health Ordinance Article III (Regulation of Food Service Facilities), for instance, establishes that operating a restaurant without a valid permit is an imminent health hazard. Some restaurants, however, will operate each year without a valid permit for longer than 4 months before enforcement action is clearly authorized by these conflicting provisions.
 - This revision to Article XIII proposes to delete the sections establishing 50% and 100% late fees, and shifts the 25% late fee to a date 30 days beyond the established renewal deadline (February 1st for all permits/licenses except vending machines which is proposed for July 1st). Retaining a 30 day grace period

provides a reasonable accommodation for permitee/licensee oversights, but removes the implicit suggestion that permits/licenses need not be renewed until several months beyond the deadline have passed.

• This revision may result in a modest loss of revenue (< \$3,000) according to estimates.

Member Carlson moved, seconded by Member Mountsier, to approve the Resolution. The Chair called for a Voice Vote on the motion. The motion carried.

 - The total of the Surplus sale is \$65,890.76.
 - This annual expense for Linen Services is estimated at \$378,500 charged to 218-4104010-71620-000-000-000-00000.
 - The cost for this contract will be paid for by personnel vacancies, utilities and related costs savings.

 - This is a request for \$26.0 million in tax exempt bond volume cap to finance a portion of the costs of the acquisition, rehabilitation and equipping of a 405 unit multifamily rental housing development located at various addresses from 2401 to 2443 West Dugdale Road in Waukegan, Illinois.

- Borrower intends to employ 250 to 300 temporary new employees during the construction period, and will employ five (5) new employees at the site of the Project within two (2) years.
- These units will be rented by low to moderate income individuals or families. Whispering Oaks Associates, L.P. will acquire, develop, rehabilitate, own and operate the Whispering Oaks Apartments.

 - On July 30th Congress passed and the President signed the Housing and Economic Recovery Act of 2008, which contained many different methods of economic stimulus packages.
 - One such element was the announcement of \$3.92 billion dollars in CDBG funds
 that would be awarded nation-wide under specific prescribed formulas and
 program requirements for the acquisition of vacant and/or foreclosed properties
 that can be acquired, rehabilitated, and sold as affordable housing for low-and
 moderate-income families.
 - Lake County was informed on September 26th that it would receive \$4.6 million dollars under the Neighborhood Stabilization Program for which HUD rules and regulations were issued on September 29th.
 - Lake County will need to develop an <u>Addendum to the 2008 Annual Action Plan</u> describing its need for these funds, the housing programs it would institute, and the mechanisms with which it will meet the funding requirements of the Neighborhood Stabilization Program. This <u>Addendum</u> must be submitted to HUD on or before December 1, 2008.
