Barry Burton presented the proposed changes to the Rules of Order and Operational Procedure. Some minor changes were made to clean and clarify existing language. Other recommended changes are as

follows:

II. Time of Regular Board Meetings - in Section A., it was recommended to delete "with the exception of the July 10, 2007 and July 8, 2008 meetings which shall be held at 7:00 p.m." thus eliminating night meetings. Due to various conflicts, it was recommended changing the following meeting dates from the second Tuesday of the month to:

Tuesday, January 20, 2009 (COW January 16th)

Tuesday, March 17, 2009 (COW March 6th)

Tuesday, June 16, 2009 (COW June 5th)

Tuesday, March 16, 2010 (COW March 5th)

Tuesday November 16, 2010 (Cow November 12th)

- B. Changed to delete "in Libertyville, with the exception of the annual budget presentation which shall occur at an evening Committee of the Whole meeting" and to add "In the conference room (at DOT) or at the Central permit Facility in Libertyville".

I. Delete "To the extent allowable by applicable law, the terms of office for appointees shall be limited to two full consecutive terms. As referenced in Section XVII(B), Appointments of Boards and Commissions, any exception to this rule shall require a suspension of the County Rules and require a two thirds (16) roll call vote of the Board Members present".

- Q. Add after Board Office "and have the committee chair notified" V. Add at the end of the paragraph "Cell phones shall be turned off during Executive Session meetings".

XVII. Appointments of Boards and Commissions

B. Replace the current "to the extent allowable by applicable law, the terms of office for appointees shall be limited to two full consecutive

terms. Any exception to this rule shall require a suspension of the county Rules (reference October 9, 1998 State's Attorney Legal Opinion and Apendix A of these Rules) with "The County Board chair shall notify board members of vacancies on other boards and commissions and seek their input in advance of the appointment".
