Mr. Williams said that news from HUD was not optimistic. The debt/deficit talks continue without resolution. While funding cuts are expected, it is uncertain which programs will be affected, and to what extent. Staff will keep the CDC updated as the talks progress.

HUD field representatives are currently on site reviewing CD's records. The representative that reviewed the Neighborhood Stabilization Program (NSP) provided a very positive exit interview earlier today. In the near future, Mr. Williams added, CDC members should expect to receive invitations to the ribbon cutting for Gabriel's Corner, LCRDC's NSP rental rehabilitation project, which was funded with the County's required set-aside for very low income citizens. According to Mr. Williams, HUD was very pleased with this project. The exit conference for HUD's review of the County's HOME program will occur tomorrow, July 28th. Once the written review is received, the CDC will be provided with the results. He then went over the updated schedule that was provided within the agenda packet, reminding the CDC that the Needs Public Hearing will be held during the regular August meeting.

The report was presented.
