## 24 <u>25-1199</u>

Joint resolution authorizing a contract with Wellpath LLC, Nashville, Tennessee, in the base annual amount of \$491,160 for juvenile healthcare at the Lake County Hulse Juvenile Detention Center and FACE-IT Residential Program.

- The current contract for juvenile healthcare services expires on November 30, 2025.
- The Request for Proposals (RFP) was sent to 23 vendors, proposals were received from three firms and interviews were held with the three firms.
- Based on the criteria set forth in the RFP, it has been determined that the proposal submitted by Wellpath LLC, is the most favorable for Lake County.

• The contract authorizes the Purchasing Agent to enter into a two-year agreement with three additional one-year renewal options that will cost the County a base annual amount of \$491,160, pending County Board budget approval.

• The base annual amount does not include Pass-Through Expenses for offsite healthcare, pharmacy, and other services.

## **25 25-1130**

Joint resolution approving an intergovernmental agreement (IGA) for part-time contractual police services by and among the Beach Park School District #3, Lake County, and the Lake County Sheriff's Office (LCSO) in the amount of \$52,065.13.

- Beach Park School District #3, and the LCSO piloted a part-time police/school resource officer program in 2016 to provide police services in the form of a police/school resource officer (SRO) at the Beach Park Middle School.
- The main objectives in having an SRO are to develop a positive relationship between law enforcement and the students, effectively deal with juvenile offenses/issues and to protect students and the school from violations of the law.
- The term of this agreement is for one year, beginning August 1, 2025, and ending July 31, 2026.
- The contract includes one part-time SRO working two days per week for 16 hours per week while school is in session.
- Beach Park School District #3 will reimburse the cost for the SRO position for the hours worked and the SRO will be assigned other duties while not serving as the SRO.

## 26 <u>25-1128</u>

Joint resolution accepting the Law Enforcement Camera Grant from the Illinois Law Enforcement Training and Standards Board and authorizing an emergency appropriation in the amount of \$54,432.

- In March 2025, the Sheriff's Office applied for the Law Enforcement Camera Grant.
- The grant allowed payment to be made to units of local government that have incurred certain types of reimbursable costs for officer-worn body cameras and each in car (dash) cameras.
- The Sheriff's Office received notification on August 27, 2025, that the grant was awarded in the amount of \$54,432.

Joint resolution authorizing the acceptance of an award with the Illinois Department of Transportation for a Sustained Traffic Enforcement Program (STEP) grant in the estimated amount of \$237,959.04 for Fiscal Year (FY) 2026.

- The Lake County Sheriff's Office (LCSO) has applied for and been awarded STEP grants since 2013.
- The LCSO has applied and received acceptance for a FY 2026 Illinois Department of Transportation STEP grant in the approximate amount of \$237,959.04 for grant period of October 1, 2025, through September 30, 2026.
- The grant reimburses the deputies' overtime wage costs and indirect costs on direct salary and wage excluding fringe.
- The main objective of the grant is to conduct specific traffic enforcement details that focus on speeding enforcement, distracted driving enforcement, impaired driving enforcement, and child passenger safety campaigns that will make the roadways safer.
- The LCSO will conduct six mandatory enforcement campaigns and all optional enforcement campaigns.
- The traffic enforcement campaigns held in Fiscal Year 2025 led to a total of 1,684 citations being issued; 118 of those citations were seat belt violations, 863 were speeding violations, 51 were distracted driving violations, and 27 arrests were made for Driving Under the Influence (DUI) of alcohol and/or drugs.

## 28 <u>25-1160</u>

Joint resolution authorizing the emergency appropriation of \$24,200 from the State's Attorney's Office Money Laundering fund to pay salary and fringe costs through the remainder of Fiscal Year (FY) 2025 for the Conviction Integrity Unit Director.

- The Lake County State's Attorney's Office (SAO) requests the allocation of \$24,200 from its Money Laundering fund to pay for salary and fringe costs.
- The Money Laundering fund has a current cash balance of approximately \$33,000.
- This appropriation is being requested as the department awaits a grant budget modification approval through the Illinois Innocence Project, which is anticipated to occur in November 2025.
- The SAO is a subgrantee on the aforementioned grant and we will then be awarded funds for our Conviction Integrity Unit Director.
- The remaining estimated salary costs are \$21,000 and fringe costs of \$3,200 through November 30, 2025.

## 31 <u>25-1209</u>

Joint resolution authorizing a Highway Authority Agreement and Supplemental Highway Authority Agreement between Lake County and Graham C-Stores Company related to property located at 221 West Rollins Road in Round Lake Beach, Illinois.

- Graham C-Stores Company owns property at the southeast corner of Rollins Road and Cedar Lake Road (221 West Rollins Road), Round Lake Beach, Illinois, which has or had leaking underground storage tanks.
- Graham C-Stores is conducting corrective action in response to the release and has requested a No Further Remediation (NFR) letter from the Illinois Environmental Protection Agency (EPA) to enable the use and redevelopment of the property.
- As a condition of granting a NFR letter, the Illinois EPA requires that property owners enter into a standard Highway Authority Agreement stating rights and obligations relative to contaminants that may have been released into nearby highway rights-of-way.
- Lake County also requires a Supplemental Highway Authority Agreement with additional rights and obligations above and beyond what is stipulated in the Highway Authority Agreement.

Joint resolution authorizing an agreement with Baxter & Woodman, Inc., Crystal Lake, Illinois, for Phase II professional engineering services for the resurfacing of Cedar Lake Road, from Monaville Road to Hart Road, which will be improved under the Illinois Highway Code for a total of 3.25 miles, at a maximum cost of \$636,741 and appropriating \$765,000 of Matching Tax funds.

- Baxter & Woodman, Inc., Crystal Lake, Illinois, will be utilized to perform the Phase Il design engineering services for the resurfacing of Cedar Lake Road, from Monaville Road to Hart Road.
- The scope of this project includes adding accessible pedestrian signals, upgrading sidewalk ramps, and modernizing the Rollins Road traffic signal.
- Lake County selects professional engineering firms in accordance with the Local Government Professional Services Selection Act, 50 ILCS 510/1 et. seq.
- The Lake County Division of Transportation's Consultant Selection Process has been approved by the Federal Highway Administration and the Illinois Department of Transportation, and the firm selected for this project was selected in accordance with this approved process.
- The selected firm has a satisfactory past relationship with the Lake County Division of Transportation.
- This project is included in the Transportation Improvement Program and designated as Section 24-00999-09-RS.

## 33 <u>25-1211</u>

Joint resolution appropriating a supplemental amount of \$30,000 of ½% Sales Tax for Transportation funds for right-of-way costs associated with the non-motorized improvements along Butterfield Road, from Gregg's Parkway to Golf Road.

- Butterfield Road, from Gregg's Parkway to Golf Road, will be improved by adding non-motorized travel improvements.
- These improvements are identified on the County's 2040 Non-Motorized Plan and are a priority gap in the path network.
- The County Board, at its July 9, 2024, meeting, appropriated \$65,000 for right-of-way costs, which is based on independent appraisals prepared for each property.
- A supplemental appropriation is needed to acquire the necessary right-of-way to construct the improvements.
- This project is included in the Transportation Improvement Program with construction planned for 2026 and designated as Section 21-00137-19-BT.

Joint resolution appropriating a supplemental amount of \$921,000 of 1/4% Sales Tax for Transportation funds and approving Change Order Number Four in the amount of \$1,294,769.65, for the intersection improvement of Winchester Road at Illinois Route 83.

- The County Board of Lake County, Illinois, at its August 13, 2024, meeting, approved an appropriation of \$3,920,000 of 1/4% Sales Tax for Transportation funds and awarded a contract to Campanella and Sons, Inc., Wadsworth, Illinois, in the amount of \$3,266,544.26 for this project.
- Change orders need to be approved by the standing committees for cumulative net increases over 10 percent.
- The sum of all change orders to date is \$1,574,366.01, which represents a 48.2 percent increase over the original awarded contract amount.
- Change Order Number Four consists of additional ground stabilization to mitigate a larger area of unsuitable soils than was included in the original contract.
- The Illinois Department of Transportation (IDOT) previously agreed to reimburse Lake County for 50 percent of the construction costs up to \$1,550,000. Lake County Division of Transportation has requested IDOT consider increasing its contribution to \$2,500,000 to help cover the additional costs.
- This project is included in the Transportation Improvement Program and designated as Section 16-00170-13-CH.

- Each year, the County Board provides guidance for development of the annual budget. The County Board approved the guidelines for FY 2026 budget preparation in April 2025, but there is a need to update them to: 1) specifically clarify the annual increase used in the budgeting for non-union employees; 2) clarify the increase in the wage scales; and 3) clarify the policy for elimination of vacant positions.
- The changes are to sections 5.9.8 (vacant position clarification), 5.9.9 (annual wage increase), and 5.9.10 (increase in wage tables). Both a clean version and a red-line version are attached.
- These clarifications are necessary to ensure consistency and compliance with the Employee Policy and Procedure Manual.

- The proposed project will demolish the existing walkway and install appropriate ADA accessible walkways on the east and west sides of the North Entrance to bring the polling station at 18 N. County Street in full compliance with ADA standards §405.2 (Running Slope of 1:12 max), §405.3 (cross slope), §405.5 (clear width), and §405.8 (handrails).
- Work will include the following: Perform necessary sitework and demolition of existing infrastructure to provide ADA §405.2 compliant slope from N. County St. and Martin Luther King, Jr. Ave. to the Lake County government parking garage entrance.
- The walkway will be of proper width, including handrails, and lighting.
- The \$250,000 in grant funding was not previously appropriated because the grant resources were secured after the County's adoption of the Fiscal Year (FY) 2025 budget.
- This is a reimbursement grant, whereby purchases are made by the County Clerk, and upon presentation of invoices and proof of payment, and approval by the Grants Program Manager, the County is reimbursed for qualified expenses.
- The grant award is for the period of July 1, 2025, through June 30, 2026.
