# 8.23 17-0604

Presentation and Endorsement of the Draft Five Year Program.

Division of Transportation Director Paula Trigg presented the Five Year Capital Improvement Program and endorsement request. Transportation remains a strategic goal of the County Board and the County has partnered with surrounding agencies to improve

the quality of life in Lake County.

The four capital revenue streams are County Bridge Tax, Matching Tax, Motor Fuel Tax, and Sales Tax. There are limitations on certain revenue sources on how funds can be expended. The County also pursues outside revenue sources via grants. The FAST Act was re-approved, which continues revenue funding for six years. Ms. Trigg identified the funds to be utilized for preserving existing infrastructure, modernizing and/or expanding infrastructure, and repaying bonds. Discussion ensued.

Member Mathias requested a list of projects in his district included in the five year plan. The consensus of the Committee is to endorse this plan.

This item was presented and an endorsement by the Committee was made.

# 8.24 <u>17-0029</u>

Director's Report - Transportation.

Division of Transportation Director Paula Trigg reported she and Principal Planner Bruce Christensen will be retiring from Lake County on June 30, 2017. Emily Kerry will take over Mr. Christensen's position. Ms. Trigg introduced Kevin Carrier as the County's new Director of Planning and Programming in the Division of Transportation. Mr. Carrier will work closely with Ms. Kerry and Senior Planner Ashley Lucas. Chair Maine requested a new contact sheet after the County hires a new Division of Transportation Director.

Ms. Trigg reported the Illinois State Toll Highway Authority has authorized a contract to complete an environmental impact study (EIS) for the Route 53 extension. The EIS will take four to five years and will include much public involvements, the results will be a matter of public record and will be released at the conclusion of the study. County Administrator Barry Burton reported he did not anticipate any information on this matter for at least 18 months but he will keep the Committee apprised of the situation. Discussion ensued.

Ms. Trigg reported the County applied for grants on behalf of Lake County Coordinated Transportation Services Committee (LCCTSC) for paratransit services. Rapid Transit Authority (RTA) is expected to award the grants in August 2017. The Project Advisory Committee, consisting of key stakeholders and the paratransit consultant, will meet on June 26, 2017 to review the technical study memorandum on the evaluation of the current situation regarding paratransit services. Potential recommendations will be forthcoming later in the year.

The Transit Team meeting included a report from RTA's staff regarding sustainable funding for coordinated demand response training. The Illinois Department of Transportation (IDOT) came out with its 2018 Improvement Program and projects in Lake County include the Route 41 and Deerpath pump station work, and the Grand Avenue, from Deep Lake Road to Deerpath Road, Road Project, the resurfacing of Grand Avenue, from I94 to Route 131. Ms. Trigg stated IDOT plans on removing the bridge on Greenwood and the Amstutz intersection. The bridge is being removed because the Amstutz will not be extended further north. Discussion ensued.

Ms. Trigg reported there is a public meeting tonight for the preconstruction discussion of the Cedar Lake Road Project. This project requires the replacement of a large culvert which will close the road for approximately 45 days.

Ms. Trigg requested approval to modify the excess property policy to include the words "if necessary" in the portion that pertains to the requirement of an intergovernmental agreement to transfer excess property to other government agencies. The consensus of the Committee was to modify the policy to include this language. Ms. Trigg recommended transferring an excess property, consisting of .07 acres, near 21st Street and IL Route 173, to the Zion Park District. The Zion Park District already mows and maintains the property and a quitclaim deed will be coming forward to committee to transfer the property to the the park district's jurisdiction.

Ms. Trigg reported on upcoming railroad work on Old McHenry Road in Hawthorn Woods, which will occur June 13 through June 16. The Rust-Oleum Golf Championship is in progress at the Ivanhoe Golf Course, from June 5, 2017 through June 11, 2017, but is not impacting traffic in Lake County. The BMW Golf Championship will be held from September 11 through September 17, 2017. Public parking will only be permitted at Six Flags Great America and volunteer parking will be staged at Hawthorne Mall. Shuttle service will be utilized to minimize the impact on County highways.

Ms. Trigg reported her staff met with other partners in Lake County regarding improving traffic safety in Lake County. A consultant has been hired to help coordinate the next steps to improve traffic safety and a meeting with key stakeholders will be held on June 15, 2017 to discuss these steps.

### 9. Executive Session

The Committee did not enter into Executive Session.

# 10. County Administrator's Report

County Administrator Barry Burton reported Bruce Christensen and Paul Trigg will retire from the Division of Transportation on June 30, 2017. The search for the Division of Transportation Director continues. Al Giertych of the Division of Transportation will serve as Acting County Engineer, pending authorization from the Illinois Department of Transportation.

Rodney Worden is being appointed to serve as the Public Works Director and will begin in August 2017.

Mr. Burton reported a judge dismissed a lawsuit accusing the Village of Fox Lake of misusing approximately \$2,200,000 in sewer fees. The judge ruled that the Regional Sanitary District did not have any authority to sue. Discussion ensued.

Deputy County Administrator Amy McEwan reported there will not be any committee meetings the week of July 3, 2017.
