Discussion of amendments to Lake County Public Nuisance Ordinance related to "non-customary outdoor storage".

Eric Waggoner and Matt Meyers presented a new category of nuisance violations, "non customary outdoor storage." The new nuisance category would be used in conjunction with Administrative Adjudication to handle more intensive outdoor hoarding sites. The proposed amendments would also allow for the abatement of accumulated outdoor storage on such properties as a last resort.

County Board Chair Lawlor stated that it is crucial to establish uniformity is assessing and identifying such violations and assisting the property owner with a written remediation plan. Mr. Waggoner indicated that the Department would work with properties owners in such cases with both a written plan and, if necessary, a phasing arrangement to remove material within a reasonable time-frame.

Committee members requested information on this new violation type that they could provide to their constituents and municipalities through their newsletters after the Board's adoption of the amendments but prior to Spring cleanup.

Eric Waggoner informed members that Robert Springer, Code Enforcement Programs Manager would be the main contact for any complaints or violations.

The amendment to the Nuisance Ordinance would be brought to the Committee for action in February 2015.

DIRECTOR'S REPORT

Eric Waggoner gave a status report on the Fox Waterway Agency (FWA). In December 2014 member Pedersen and staff met with members of the FWA and offered a number of potential sites located within the Chain O' Lakes suitable for dredging material. Staff also presented a draft process for regulating staging and processing sites. Member Pedersen thanked staff for taking the time to meet with FWA and show them the properties. Draft amendments are being prepared for Committee discussion in March.
