At the hearing ICC approved giving the County \$12 million from the Rollins Road and Route 83 project. The Washington Street project has been approved and will start in July 2013. A full closure of Cedar Lake to Hainesville will result in a 4 month construction project as opposed to 9 1/2 months. Detour routes will be available during the road closure.
