## 7.1 10-0472

Overview of Proposed Revisions to Lake County Board of Health Ordinance Article X (Animal/Rabies Control). Information only.

Mark Pfsister, Health Department presented to the committee information regarding revising the LC Board of Health Article X (Animal/Rabies Control). In the coming months Population Health Services (PHS) intends to propose revisions to the Lake County Board of Health Ordinance Article X, and would like to inform the Committee of the substance of these changes. Prior to bringing any proposed revisions to the Board for approval, PHS will obtain concurrence from our Advisory Committee and will conduct a public hearing to obtain community input.

The revisions are being made in order to remove redundancies and/or conflicts between the existing ordinance and the Illinois law that set statutory requirements for animal care and control. The specific revisions that will be proposed are to:

- incorporate by reference and/or state that all actions regarding the care and control of animals shall be in accordance with the Illinois Animal Control Act, Animal Welfare Act, Humane Care for Animals Act, Dangerous Animals Act and Dead Animal Disposal Act;
- remove language that is duplicative or which contradicts the requirements of the acts listed above:
- clarify the administrative language sections and make them consistent with the requirements of the acts listed above; and
- evaluate and potentially revise, add or eliminate requirements in Article X that are more stringent than the requirements of the acts listed above (e.g., the 5 foot leash requirement).

In addition to these revisions to Article X, PHS intends to develop an Administrative Policies and Procedures document that will be referenced in, and accompany the ordinance. This document will provide more detailed descriptions of the departmental polices and procedures to be followed when implementing the requirements of Article X in order to assure continuity and consistency in the implementation of Article X in the future.

Public Hearings are expected to be held this fall.

Mr. Hunt, Planning Department, presented the Brownfield Grant Applicants.

1. Barrington is requesting \$75,000 for asbestos removal and disposal from the ADCO Van & Storage warehouse and office built in 1941 and expanded in 1954, located at 322 North Hough Street. The property also might have contamination caused by leaking underground fuel storage tanks on adjacent properties. The Village owns the 1.2 acre property, which is located in the Village Center Tax Increment Financing District. The Village intends to either convert the existing building for a retail user or teardown for redevelopment. There is no end user at the present time and Barrington will not begin clean up activities until there is a user. The Village estimates that 5 – 10 people will be employed during site cleanup and estimates that 25 – 50 people would be employed in a 20,000 square foot retail business. The Village anticipates that redevelopment and/or a new user for the property will be secured by fall 2010 with construction completed within 120 days of having a tenant. A new business would begin operation in spring 2011. 2. Kildeer is requesting a grant of \$60,000 for remediation at a former auto service station and auto sales lot on approximately 8 acres that will be the Kildeer Marketplace Planned Unit Development. The property is located on the northwest corner of the intersection of Plum Grove Road and Rand Road (US Route 12). Remediation activities include removing underground fuel storage tanks and discarded auto parts, plus the demolition of existing buildings. The application mentions constructing a stormwater management system but since this will not directly reduce or eliminate site contamination it is not a qualified Brownfield Grant expenditure. The plans for the redevelopment of the property include three new buildings with over 65,000 square feet. End users are Whole Foods and Bank of America, plus additional general retail shop space. Kildeer estimates that there will be 6 cleanup jobs and 100 construction jobs. Whole Foods is expected to have

160 employees; Bank of America 20 employees; and 50 employees in the retail space. Non-construction employment is expected by July 1, 2011.

3. North Chicago has applied for \$75,000 to remediate a site of 11 acres, owned by the City of North Chicago. The subject property, and the adjoining parcel to the west, were once the North Chicago Municipal Dump / Landfill. The landfill was used for municipal household and commercial garbage from 1971 to 1976. Contaminants include organics and heavy metals typical of household, institutional and industrial waste. Decomposition of the buried waste creates methane and leachate. The property is north of Pulaski Drive, and abuts ComEd power lines on the east. The Green Belt Forest Preserve is north, west and east of the property. The end user in the grant application is Whole Earth Organics and the proposed use is a yard waste compost facility. An estimated 14 to 17 people will be employed during the cleanup; 6 will be employed during construction; and there will be 5 – 7 full time jobs at the compost facility, which is expected to begin operating by September 2010. Methane recovery for energy generation (landfill gas to energy) is a possibility and if this proves viable, an additional 20 – 30 people will be employed. The Energy Plant would come online in late 2011.

The committee asked many questions and the applicants will have an extra day to respond with more information.
