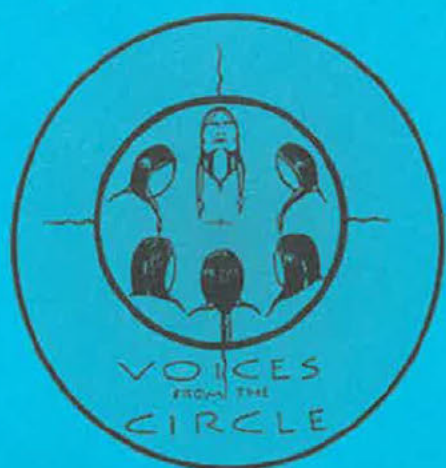

AMERICAN INDIAN EDUCATION/CULTURAL PRESENTATIONS

Jim De Nomie is an enrolled member of the Bad River (Meshkazeabee) Band of Chippewa (Ojibwe) Indians (Anishinabe) of Lake Superior. Originally from Milwaukee, Mr. De Nomie earned his B.S. Degree in Mass Communications from the University of Wisconsin Oshkosh campus. He serves as an American Indian cultural presenter and consultant to schools and organizations on all levels; community colleges, universities, religious groups, service organizations and major corporations have come to rely on him for a unique native perspective with special focus on the Woodlands and Western Great Lakes areas of the United States.

These presentations have taken him to California, Colorado, Florida, Illinois, Michigan, Minnesota, New Mexico, Wisconsin, Ontario Canada and Chiba Japan, *I-LAN TAIWAN*

The most requested presentations made by Mr. De Nomie are;

1. Living a typical day in tribal/ancient times -- Pre European Contact
2. American Indian & U.S. Government policies -- 1776 to Present
3. Treaty Rights -- Perspectives of Indians and non-Indians in today's society
4. Cultural Sensitivity -- There is a difference between tribal and mainstream ways
5. Mini Pow Wow -- Discussion and demonstration of song and dance styles plus audience participation
6. Architecture B.C.(Before Columbus) -- An examination of the Native building styles of North America

Incorporated into the content of Mr. De Nomie's presentations are facts about his family, reservation and tribal historic facts. Additionally, he shares information about other woodlands tribes, traditional tribal regalia, native concepts of spirituality and the native world view of our Mother, the Earth, and our relationship to Her. Audience members are encouraged to ask questions about the rich, ancient cultures of the original inhabitants of the Americas.
