Resolution designating voting sites in Lake County for 2012.

- The 2011 decennial redistricting resulted in new Congressional, State and County Board district lines creating the need to reconfigure Lake County's voting precincts.
- In order to provide more equitable service on Election Day and conserve the increasing costs to taxpayers, the number of voting precincts was reduced by 66 resulting in a total of 415 precincts in Lake County.
- The advent of early voting alternatives, has resulted in more than one-third of Lake
 County voters now voting prior to Election Day, thus reducing the number of voters at the
 polls on Election Day.
