Lake County	Alexian Brothers – The Harbor	\$110,250	Provides renewal funding for 9 units of transitional housing, up to 24 months, for homeless men and women living with HIV/AIDS who also have a history of substance abuse and/or mental illness.
Catholic Charities	Catholic Charities CTI-RP Program: Case Mgmt. Component	\$187,128	Provides renewal funding for the Critical Time Intervention (CTI) Case Management services for chronically homeless persons in the Shields Township Shelter Plus Care program. The program will provide intensive case management services.
Lake County	Catholic Charities Supportive Services for the Homeless	\$45,507	Provides renewal funding for housing counseling services to move 25 homeless persons from emergency or transitional housing into permanent housing.
Lake County	COOL Transitional Housing	\$42,290	Provides renewal funding for transitional housing, up to 2 years, for 2 homeless families through 2 scattered-site housing units located in Waukegan.
Lake County	Independence Center Permanent Housing	\$58,184	Provides renewal funding to maintain 8 units of permanent supportive housing for homeless persons with mental illness.
IPLUS	IPLUS CTI-RP Program: Rep. Payee Component	\$34,874	Provides renewal funding for Representative Payee services for chronically homeless persons in the Shields Township Shelter Plus Care program. The program will receive each client's benefit check and work with the client to pay rent, utilities, and other bills necessary to maintain housing.
Lake County	Lake County Haven	\$46,274	Provides renewal funding for transitional housing, up to 2 years, for homeless women and children via 2 scattered site apartments and condominiums located in Libertyville.
Lake County	Lake County HMIS	\$95,648	Provides funding for a HUD-required information system, locally known as ServicePoint, which maintains data about homeless clients. Provides funding for a full-time staff person dedicated to administering and improving the system.
Lake County	LCRDC SAFE Housing (Mary Pat Maddex)	\$82,766	Provides renewal funding for 9 units of transitional housing, up to 2 years, for homeless women with children who are recovering from substance abuse addictions. Program contracts with Catholic Charities to provide on site supportive services.
Lake County	PADS Resource Center	\$137,331	Provides renewal funding for emergency shelter and supportive services to homeless men, women, and children via a fixed-site, year-round emergency shelter, a daytime drop-in facility, and 12 seasonal rotating site shelters located in area churches.
PADS	PADS Safe Haven	\$226,376	Provides renewal funding for 15 low-demand "Safe Haven" housing units for chronically homeless persons who suffer from severe mental illness and/or chronic substance abuse.
Prairie State	Prairie State Legal Services – Legal Advocacy for Housing Options	\$50,000	Provides renewal funding to provide legal advice and representation to low/moderate income tenants and homeowners who face imminent homelessness due to unlawful lockouts, illegal evictions, wrongful loss of Section 8 housing subsidies, or foreclosures.
Lake County	Waukegan Township Staben House	\$184,940	Provides renewal funding for transitional housing, up to 2 years, for homeless women and children at a site located in Waukegan.
Lake County Health Dept.	Shelter Plus Care	TBD (price based per unit)	Provide renewal funding for permanent housing subsidies for chronically homeless individuals and families with behavioral health issues.
Shields Township	CTI-RP: Housing Component	TBD (price based per unit)	Provides renewal funding for the rent subsidies in the CTI-RP Program for chronically homeless persons. The program partners with Catholic Charities and IPLUS to provide intensive case management services and representative payee services.
