On March 1, 2024, the Centers for Disease Control and Prevention (CDC) released updated Respiratory Virus Guidance. The Illinois Department of Public Health (IDPH) announced that it is adopting the CDC updated guidance that streamlines and simplifies recommendations for dealing with the range of respiratory viruses, including COVID-19, flu, and RSV.

The updated guidance no longer requires those who test positive for COVID-19 to isolate for a minimum of five days before returning to work or other activities. Instead, it focuses on isolation until symptoms improve – which could be shorter or longer than five days. The key recommendation for those with any seasonal respiratory virus is to stay home and away from others until their symptoms improve.

The guidance suggests people can return to normal activities when symptoms have been improving for 24 hours—and if a fever was present, it has been gone for 24 hours without use of a fever-reducing medication.

In addition, once people resume normal activities, they are encouraged to take precautions for the next five days to curb disease spread including:

Getting tested to inform your actions to prevent spread to others

Wearing a well-fitting mask

Keeping a distance from others

Enhancing hygiene practices

Taking steps for cleaner air

World TB Day

On March 24 each year, we recognize World TB Day. This annual event commemorates the date in 1882 when Dr. Robert Koch announced his discovery of Mycobacterium tuberculosis, the bacillus that causes tuberculosis (TB).

Many people still suffer from TB. If left untreated, 1 in 10 people with latent TB will get sick with active TB, which can spread to others and be deadly.

The Health Department's Tuberculosis Clinic provides screening, testing, consultation, education, treatment, and home visits for anyone living, attending school, or working in Lake County.

National Groundwater Awareness Week

In Observance of National Groundwater Awareness Week, the Lake County Health Department is offering a reduced well water testing fee for homeowners who use well water as their primary source of drinking water.

Between March 10 and March 22, 2024, the normal \$18.00 fee for testing for bacteria and

nitrates will be reduced to \$15.00.

Sterile test bottles and sampling instructions are available at the Lake County Central Permit Facility at 500 W. Winchester Road, Libertyville, the Health Department's headquarters at 3010 Grand Avenue, Waukegan, and 19 township or municipal offices located throughout Lake County.

While most of the time, U.S. groundwater is safe to use, testing groundwater can help ensure that it has not become contaminated with germs and chemicals that could make people sick.
