

AN ORDINANCE OF THE CITY OF NORTH CHICAGO TRANSFERRING JURISDICTION OF MARTIN LUTHER KING JR. DRIVE FROM ILLINOIS ROUTE 131 TO LEWIS AVENUE FROM THE CITY OF NORTH CHICAGO TO THE COUNTY OF LAKE HIGHWAY SYSTEM NORTH CHICAGO, LAKE COUNTY, ILLINOIS

WHEREAS, a segment of Martin Luther King Jr. Drive (hereinafter "MLK DR.") that is approximately 0.53 miles in length is currently under the jurisdiction of the City of North Chicago (hereinafter "CITY") as depicted on the map attached as Supplement 1; and

WHEREAS, the County of Lake (hereinafter "COUNTY") is desirous to assume jurisdiction of a segment of MLK DR. from Illinois Route 131 to Lewis Avenue in its entirety; and

WHEREAS, the 1970 Illinois Constitution, Article VII, Section 10, and 5 ILCS 220/1, et seq. authorize the COUNTY and the CITY to cooperate in the performance of their responsibilities by contract and other agreements; and

WHEREAS, the COUNTY and the CITY have executed a project specific intergovernmental agreement for the improvement of MLK DR. stipulating the desire of the parties thereto to transfer jurisdiction of MLK DR. to the COUNTY; and

WHEREAS, the COUNTY and the CITY have prepared a Local Agency Agreement for Jurisdictional Transfer providing for the transfer of the aforementioned segment of MLK DR. from Illinois Route 131 to Lewis Avenue in its entirety, to the COUNTY. Said Local Agency Agreement for Jurisdictional Transfer is attached as Supplement 2; and

WHEREAS, the State of Illinois requires that said action be effectuated by the passage of an ordinance by the CITY.

BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF NORTH CHICAGO, LAKE COUNTY, ILLINOIS, pursuant to its home rule powers, Section 6 of Article VII of the Constitution of the State of Illinois, as well as all other applicable authority that

MLK DR. from Illinois Route 131 easterly to Lewis Avenue, in its entirety, that is approximately .053 miles in length, be removed from the CITY'S municipal street system and that the Mayor is hereby authorized to execute the aforementioned Local Agency Agreement for Jurisdictional Transfer.

SECTION 1: All ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 2: This Ordinance shall be in full force and effect after passage, approval and publication in pamphlet form.
