CLCJAWA is eager to add new members, however, new members are not eligible to vote at board or executive meetings until they become full members. Lake County is funding all costs of the project, which will be shared with Lindenhurst and Lake Villa, based on the size of their current water system. Lake County is only allowed a 10% future expansion of the system, in which CLCJAWA will not charge for new connections, however the villages may.

Report on the draft agreement for retail sanitary service to the Village of Bannockburn.

Peter Kolb, Public Works, presented the report. The transfer of the local lines to the County is projected to take place in September.

Peter Kolb, Public Works, apprised the committee that the SSA #16 public notices are being mailed in July. Public Works is working with North Chicago's Arden Shores area to upgrade its outdated water system. A recent audit on Public Works funds was explained in detail, and that the findings of the audit will not result in increased bond obligations. A handout was provided showing direct payment customers. Members were also advised of an emergency repair to a water main break in a forest preserve. Discussion followed.

Building a bridge across Lake Cook Road into Cook County, a Chain O' Lakes bike path, and adding a study for bike path corridors are to come. A map was provided showing projects in process, programmed, and finished. Lastly, Paula explained how monies are budgeted across the projects, and where the revenue comes from.
