Brownfield Program

7.1 09-2141

Joint resolution authorizing an Amendment to the Intergovernmental Agreement with the City of Waukegan to extend the timeframe for the expenditure of 2008 Brownfield Funds.

- In October 2008 the County Board executed an Intergovernmental Agreement with the City of Waukegan for a Brownfield Grant for up to \$100,000 for clean-up activities at the Former Harbor Slip 3.
- The resolution would authorize the Chairman to execute an Amendment to the Intergovernmental Agreement with Waukegan to extend the timeframe for the City to request reimbursement of Brownfield Funds from October 2009 until October 2010.
- Waukegan Mayor Bob Sabonjian sent a letter to the County Board dated October 13, 2009 stating the City prefers an extension of the Former Harbor Slip 3 Brownfield project rather than funding for a new project.

Bill Hunt, Planning, Building and Development presented this resolution. Member Cunningham said that this project was not shovel ready. She had spoken to the developer at the Market Street project and they are in need of the funds right now. She made a motion to award the grant to the Market Street applicant. Member Maine seconded the motion. Ron Laubach, City of Waukegan, assured the Board that the city of Waukegan was in support of this former Slip 3 Project Resolution and not the Market Street project. - The new grants and additional revenue for the Health Department totals \$2,709,564 and a complete list of the sources of these funds is included in the resolution.

H1N1 Influenza Update (Information only)

 Jerry Nordstrom, Director of Administration, will provide a verbal update on the Health Department's H1N1 Vaccine campaign and current H1N1 related issues facing the department.

Jerry Nordstrom and Victor Plotkin, from the Health Department presented an H1N1 Vaccination Update to the committee and answered members questions. Mr. Nordstrom said the vaccination clinics were chosen according to location of the greater population of those under the age of 24, which are in the priority or "high risk" group. The Health Department did not anticipate that they would be the only Lake County agency to receive the vaccine. The Health Department vaccinated more than 10,000 people in less than two days and hopes to recieve another

shipment in two weeks (but does not have a confirmation date). Over 430 agencies have registered to receive the vaccination and at this time no one knows when they will receive a shipment.

Committee Action for the Lake County Affordable Housing Program: Request for a change in Project Location.

- The Lake County Affordable Housing Program Criteria contains the following requirement "post-award changes in project location are subject to Health and Community Services Committee approval."
- Habitat for Humanity received a 2008 grant award of \$69,960 to acquire sites on the north side of 11th Court in Waukegan (Carter Crossing).
- Ms. Julie Donovan, Executive Director, will present a request to instead purchase a site on the same block, but which is on the south side of 11th Street in Waukegan (that is still within the same project development).
- Staff recommends Committee approval.

Judy Gathman, Community Development and Julie Donovan from Habitat for Humanity presented a committee action request for a change in project location for the Carter Crossing Project.

- At the present time, the anticipated review and presentation schedule allows for Committee presentations February 2010 and County Board approval March 16, 2010.
