6. OLD BUSINESS

6.1 12-0933

Presentation by the Lake County Sustainable Local Food Systems team.

David Husemoller, Planning, Building and Development Department introduced Jason Navota from the Chicago Metropolitan Agency for Planning (CMAP).

Jason Navota summarized the demand for locally produced agricultural products, the infrastructure and other challenges in expanding local food systems, and how Lake County can take significant steps towards capitalizing on the economic, environmental, and health benefits associated with locally grown food. He further discussed the collaboration efforts in producing the final draft of the Lake County Sustainable Local Food Systems report as well as recommendations for continuing to promote local food systems in Lake County.

Pat Carey, County Board Member, noted her strong support for the local food initiative, and asked for her fellow Board Members to participate in and promote the initiative from the standpoint of sustainability and economic development.

Aaron Lawlor, County Board Chairman, expressed the importance of targeting certain geographically isolated "food deserts" within Lake County in order to provide the benefits to all County residents. He also noted the importance of outreach at this time to the Lake County Farm Bureau and Lake County Partners to encourage their participation in the initiative going forward.

CMAP requested that the County continue to support the Sustainable Local Food Group by offering staff resources.

The Committee agreed that David Husemoller should continue as the staff liaison to the Sustainable Local Food Group.

STORMWATER MANAGEMENT COMMISSION

7.1 13-0474

Joint resolution authorizing an emergency appropriation in the amount of \$750,000 to be used for the demolition, site restoration and project management of the Gurnee Grade School, District 56, 900 Kilbourne Road, Gurnee, Illinois, Lake County.

Presented by Mike Warner, Executive Director, Stormwater Management Commission.

Mr. Warner stated that the former Gurnee Grade School did flood during the recent rain events. The benefits of Committee approval of funds for demolition of the school were already recognized as the children were not displaced by the flooding.

7.2 13-0519

Joint resolution authorizing the waiver of flood repair-related permit fees and the reduction of septage disposal fees.

Presented by Eric Waggoner, Director, Planning, Building and Development Department. Mr. Waggoner stated the goal is to give some financial relief to property owners affected by the floods and incentivize their use of disposal and permit services if necessitated by flood damage. The reduced septage disposal rate will be in effect upon County Board approval through June 1, 2013; the permit fee-waiver will be in effect upon County Board approval through August 1, 2013 with extensions granted on a case-by-case basis.
