INTENT:

The modernization will include but not limited to new AC motors, VFD motor controllers, microprocessor elevator control systems, new door protection, door restrictors, gibs, car operating panels, position indicators, floor passing signals, hall stations, lobby panels, automatic terminal limits, car top inspection stations, traveling cables, wiring, and a BACnet/IP building automation interface. The Jail will be occupied while work is being conducted, contractor will only be allowed to modernize one elevator at a time and be responsible for the operation and maintenance all three detention elevators to assure Jail operation is not effected by the work.

DEPARTMENT RECOMMENDATION:

On June 20, 2017 at 2:00 p.m. Lake County Purchasing Division received and opened 3 bids for Elevator Modernization. thyssenkrup elevator is the apparent low responsive and responsible bidder. Therefore, it is my recommendation to award this contract to the lowest responsive and responsible bidder, thyssenkrup elevator.
