ORIGINAL NARRATIVE

On 11-23-21, I (Det. Brasewicz) was notified by Assistant State's Attorney Dan Brown of a subject, Julie Brockman-Volk (DOB 09/10/68), who has applied for a massage license through the county but may be operating the business before obtaining the license. ASA Brown sent me a copy of the application (see attached) which has an affidavit that was signed and notarized on 10/28/21.

ASA Brown provided me with a link to Julie's website "touchedbyjules.com". I went on the website and discovered that it shows one massage location as 611 Rockland Rd Suite 2 Lake Bluff, IL 60044 (see attached screenshot) which is the location she applied for a license for. Appointments could be made by calling or texting 630-927-9867.

On 11-23-21, I sent a text to the number from my CID issued cell phone asking if they were open and if I could schedule an appointment, but I received a reply saying that they were open but there were no openings for that day. I sent another text on 12-3-21 asking if there was any availability at the Lake Bluff location, she replied yes and that she had availability on Thursday 12-9-21 at 3pm. Julie advised that it would be \$120 for an hour which I agreed to. See attached screenshots of the text conversation.

On 12-09-21 at approximately 1230hrs, I went to the massage business located at 611 Rockland Rd Suite 2, Lake Bluff, IL 60044 to speak with Julie about the ordinance violation. There was no answer at the business and no answer on her cell phone, so I waited outside. At 1300hrs, Julie returned to her business and I spoke with her. Julie gave the following verbal statement which is not verbatim. Julie let me inside of her business which appeared to be a fully functional massage establishment. I advised Julie that I am the investigator for the liquor commission and asked if she was aware that she had to have a license from the county before she could operate her business, she said yes. I advised her that she is operating without a license, but she said she is not operating yet. I then advised her that I had scheduled an appointment with her at 3pm. I explained that the liquor commission reached out to me about her business violating county ordinance #114.03 which is operating without a county issued license. Julie said that she has been waiting long for the commission to give her the license and that she cannot pay her bills. Julie stated that there are other people in this business and in the county that are operating without a license as well.

I gave Julie non-traffic citation #801179 for violating ordinance #114.03 for operating without a license. I explained how to attend the court hearing online via zoom (see attached copy of ticket). I explained that she can no longer operate her massage business in Lake County until she receives a license. I advised Julie to contact the liquor commission about her concerns with the application process. My body worn camera was activated and recording. I reviewed the video prior to writing this report.

End of report.
