Christina Douglas of A Safe Place emailed her public comment for Item 6.1: A Safe Place thanks the Commission for recommending our organization for HOME funding. For 43 years, A Safe Place has provided services to victims of domestic abuse and their families and is the sole service provider that is devoted exclusively to addressing domestic violence and human trafficking in Lake County, Illinois. The COVID-19 pandemic has led to an unprecedented increase in victims seeing assistance from A Safe Place in 2020 – 2021 and the increased demand for services is likely to continue for the foreseeable future. As compared to pre-pandemic service numbers, A Safe Place has experienced a 635% increase in calls to our 24-hour Crisis line, and as recently as last month we were sheltering four times more people as compared to March 2020. Housing is the top need identified by callers to our hotline and 211 statistics confirm that as well. A Safe Place has provided emergency shelter since 1979, 37 units of Section 8 housing for 12 years, transitional housing for 12 years, 30 units of VOCA Shelter of Hope housing for 4 years, and Rapid Rehousing for 2 years, and has managed a major increase in the need for emergency shelter. Using Maslow's Hierarchy of Need and the Housing First model, we know that only when people have their basic needs met (housing, food, etc.) are they able to then address the trauma they have experienced and work to rebuild their lives. The requested funds will allow us to create a new housing option for victims and their children that does not require them to live in a hotel... this is especially important for victims of Human Trafficking who were typically trafficked in hotels. We will also be able to have an A Safe Place staff member on-site at the home to assist clients in carrying out their Service Plans. Again, thank you for your support.

Bev Saiz of Clearbrook entered her public comment within the meeting chat box: Thank you for your support of Clearbrook and those we serve. We are very appreciative of your support.

Robert Montgomery of UMMA wrote his public comment in the meeting chat box: Thank you everyone for your continued support of UMMA.

 - Supplemental funding for previously approved projects including a senior housing construction, affordable housing rehab and resale, a community integrated living arrangement and down payment assistance.
 - Reallocation of prior program year funding to support the acquisition and rehabilitation of scattered site properties from the Lake County Housing Authority (LCHA).
 - Change in subrecipient from Lake County Administrator's Office to the Independence Center for facility improvements at the Living Room Wellness Center.
- Contingency fund approvals will be subject to specific administrative approval mechanisms and Board Committee reporting requirements for contract contingencies.
