**Department Recommendation:**

Lake County Purchasing received an opened 3 proposals in response to the orthoimagery and oblique imagery for Lake County. Two vendors were invited to participate in the shortlist interview process. Nearmap, US Inc. was selected as the top-rated vendor. Nearmap, US Inc. has the expertise and background to perform all the duties defined in the RFP. Nearmap can deliver an annual, multi-capture digital orthoimagery/oblique imagery starting in the Spring of 2020. Nearmap can provide multiple captures a year {i.e. Spring (March/ April), Summer (June/July) and Fall (October/November) and can be accessed through the creation of its cloud-based delivery system. Additionally, Nearmap, US Inc. agreed that the spring orthoimagery will be provided each year in an offline format and Lake County will retain that in perpetuity. Lake County will also have rights for full redistribution of the even year spring offline copy.
