#### 8.2 25-0700

Joint resolution authorizing a contract with Precision Pavement Markings, Inc., Pingree Grove, Illinois, in the amount of \$1,355,818.39 for the removal and replacement of pavement markings, and the removal and replacement of pavement markers on various county highways, which will be improved under the Illinois Highway Code for a total of 99.7 centerline miles and appropriating \$1,627,000 of Motor Fuel Tax funds.

- Lake County maintains over 300 total centerline miles and more than 900 total lane miles of pavement markings and pavement markers for medians, lane lines, and cross walks.
- There was a public call for bids, and a total of two bids were received, ranging from \$1,355,818.39 to \$1,748,227.15, and the lowest responsible bidder is Precision Pavement Markings, Inc., Pingree Grove, Illinois, in the amount of \$1,355,818.39.
- This project is included in the Transportation Improvement Program, and designated as Section 25-00000-15-GM.

# 8.3 <u>25-0701</u>

Joint resolution appropriating \$500,000 of ½% Sales Tax for Transportation funds for the acquisition of necessary right-of-way, by agreement or condemnation, and other right-of-way costs associated with the improvements to the intersection of Kenosha Road at 21st Street.

- The intersection of Kenosha Road at 21st Street needs to be improved.
- The scope of the work includes the installation of a roundabout and non-motorized improvements.
- Preliminary engineering plans and right-of-way plats identifying the right-of-way needs for the improvement have been prepared.
- This project is included in the Transportation Improvement Program with target construction in 2027 and designated as Section 19-00125-07-CH.

## 8.4 25-0731

Joint resolution authorizing a contract with Campanella & Sons, Inc., Wadsworth, Illinois, in the amount of \$9,170,788.90 for improvements to the Robert McClory Bike Path, from Russell Road to Broadway Avenue and from Old Elm Road to Vine Avenue, for a total of 12.3 miles and appropriating \$11,005,000 of ¼% Sales Tax for Transportation funds.

- Improvements to the Robert McClory Bike Path include paving the gravel path with asphalt, resurfacing the existing asphalt, concrete repairs, ADA upgrades, drainage improvements, increased local connectivity, and other related work.
- There was a public call for bids, and a total of one bid was received, in the amount of \$9,170,788.90, and the lowest responsible bidder is Campanella & Sons, Inc., Wadsworth, Illinois, in the amount of \$9,170,788.90.
- This project is included in the Transportation Improvement Program with construction to begin in 2025 and designated as Section 23-00999-94-BT.

## 8.5 25-0702

Joint committee action item approving Change Order Number One with Christopher B. Burke Engineering, Ltd., Rosemont, Illinois, consisting of an increase of \$160,033 for additions to the Robert McClory Path Phase II engineering services contract.

• Change Orders need to be approved by the standing committees for cumulative net increases over 10 percent.

- The Robert McClory Path project is under contract with Christopher B. Burke Engineering, Ltd., Rosemont, Illinois, in the amount of \$1,034,002 as approved by the County Board on September 12, 2023, and designated as Section 23-00999-94-BT.
- Change Order Number One includes the design engineering, environmental agency coordination, and permitting to improve the crossings at Golf Road, Illinois Route 132 (Grand Avenue), Washington Street, and Belvidere Road, which are all four or five lane roadways.
- This is the first contract change order to date in the amount of \$160,033, which represents a 15.5 percent increase over the original awarded contract amount.
