# 9. County Administrator's Report

Walter Willis, SWALCO and Michael Kuhn, Health Department provided an update on the air quality permit for Countryside Landfill.

Kimberly Thoede and Barbara Klipp from Incinerator Free Lake County expressed concerns that Countryside Landfill is in non-compliance with the EPA regarding the air quality. Information obtained from Illinois EPA regarding Countryside Landfill, Grayslake has been non compliant on their tentative levels of sulfur dioxide for the past 2 years. Despite a federal notice of violation in February 2010. The Land Fill has filed a request for a permit to the Illinois EPA to be allowed to increase their sulfur dioxide emission level from current 27.49 tons per year to 97.5 tons per year. If granted, these levels could be just short of being classified as a major source of pollution as defined by the Clean Air Act. Given the history of non-compliance and the problems at the Landfill, Incinerator Free Lake County is expressing opposition to the permit request. While the Illinois EPA will not make a decision on the permit amendment until June, it is the hope that the Lake County Board will support the efforts of Incinerator Free Lake County for Countryside Landfill to adhere to their permitted levels and install the technology to help the clean up process and decrease the emission levels especially since they are in close proximity to schools, churches, shops, downtown areas, workplaces and residential neighborhoods.

The committee has requested the staff to prepare a letter for the Chairman to send to the EPA, the essence of the letter should be "a scrubber should be installed and operating to prove that new elements will work before the EPA considers approving the new permit".

Mike Kukn and Walter Willis explained that emissions up to 100 tons are allowed with a permit. The other Land Fill in Lake County already has a permit that would allow emissions at this level.
