8.2 26-0121

Update and discussion regarding the State of Illinois 2026 Legislative Sessions.

Derek Blaida, Strategic Advocacy Group, provided a summary of the State of Illinois 2026 legislative session thus far. Topics included: SB 2941 (Amendments to Regional Transportation Authority Act) and legislation pertaining to vexatious Freedom of Information Act (FOIA) requests. Discussion ensued. Mike Grady, Strategic Advocacy Group, assisted in answering questions from the Committee.

Discussion ensued regarding SB 2279/HB 3320 (Illinois Responsibility in Firearm Legislation or "RIFL" Act). Dr. Anthony Douglas II, RIFL Act Coalition, assisted in answering questions from the Committee. The following Members were in support of the RIFL Act: Vice Chair Campos, Member Frank, Member Vealitzek, and Chair Wasik. The following Member was not in support: Member Hunter. Members Roberts and Schlick were absent. Therefore, the consensus of the majority of the Committee was to add the RIFL Act to the 2026 Lake County Legislative Agenda as an item to support.

8.3 26-0122

Update and discussion regarding Federal Legislative items.

Matt Meyers, Deputy County Administrator, introduced Clayton Cox and Scott Binkley, McGuire Woods Consulting, LLC, who provided a summary of the Federal 2026 legislative session thus far. Topics included: the most recent federal government shutdown and Community Project Funding for Lake County projects. Discussion ensued.

8.4 26-0137

Discussion and presentation related to filed State and Federal Bills.

Matt Meyers, Deputy County Administrator, noted that discussion regarding bills of interest to the County occurred during items 8.2 and 8.3.

8.5 26-0178

Discussion regarding a proposed National Association of Counties (NACo) interim policy resolution.

Matt Meyers, Deputy County Administrator, explained that the National Association of Counties (NACo) annually solicits policy resolutions from membership counties to be included in their American County Platform. Deputy County Administrator Meyers noted that Jennifer Clark, Lake County Technology Committee Chair and Vice Chair of the NACo Technology and Telecommunications Committee, added her name to a NACo interim policy resolution, to be considered at the upcoming NACo Legislative Committee, regarding preserving state and local authority to set policies related to Artificial Intelligence (AI). Discussion ensued.

The consensus of the majority of the Committee was to support submitting the aforementioned interim policy resolution to NACo.
