Presentation on the extensive review process conducted to evaluate the bids received for the management, staffing, and daily operation of Winchester House, as well as an overview of the proposed agreement.

Presented by Ryan Waller, Assistant County Administrator, Barry Burton, County Administrator, and Craig Abbott, Health Dimensions Group.

Member Bush entered the meeting at 1:05 p.m. Member Paxton entered the meeting at 1:06 p.m. Member Mountsier left the meeting at 1:34 p.m.

Mr. Waller gave background on Winchester House, the mission, the direction to seek bids from private operators, and the review process. He noted that the review process was

extensive and which concluded in a unanimous recommendation to award an agreement to manage and staff Winchester House to Health Dimensions Group (HDG), Minneapolis, MN. HDG operates 22 facilities in four states. Several of those facilities were previously owned by counties and municipalities. HDG also places a strong emphasis on resident care and performance measurements.

Mr. Abbott addressed the committee and provided a background of HDG, their mission, and their qualifications.

Mr. Waller distributed letters of recommendations from other counties that have partnered with HDG.

Mr. Waller read a letter from Ric Olson, Winchester House Advisory Board Chair, supporting the recommendation.

Michael Knight, Winchester House Advisory Board, commented to the committee that he is strongly supportive of the recommendation to award to HDG.

Discussion ensued.

Public comment: George Merrill, Lake County United, spoke in favor of Health Dimensions Group.

Mr. Waller noted an agreement would be provided at the October 4, 2011 Health and Community Services committee meeting for consideration.
