County Board Member Ann Maine stated that as the representative for this area, she would be in favor of extended hours and additional months for landscape waste burning. The committee concurred and directed staff to modify the proposed regulations to:

Remove the limitation on the months that burning can occur. Burning permitted year round.

Weekdays - Allow burning from 5 p.m. to 8 p.m. or sunset, whichever is earlier.

Weekends - Allow burning from 12 p.m. to 8 p.m. or sunset, whichever is earlier.
