7.4 <u>12-1421</u>

Presentation on the Lake County Sheriff Marine Patrol Unit.

Presentation on the Lake County Sheriff's Office Marine Unit by Officers Kent and Lyons. The Marine Unit operates on the Chain of Lakes during the peak hours of Thursday through Sunday with a staff of 20 part time officers. An estimated 27,000 boat permits were issued in 2012. The Marine Unit has conducted 1,177 boardings resulting in 541citations. There was a noted increase in activity on the lakes in 2012 due to the warm weather conditions. The Marine Unit is funded through the Sheriff's Office budget and generates a small amount of money through fines. If established, the Sheriff's Office will participate in a task force to improve safety on the Chain of Lakes.

A discussion followed about a way to increase revenue for the Marine Unit by means of a public safety fee. Currently, there is no interest by the Fox Waterway Agency to allow Lake County to add a fee to the existing licensing process to generate funding. Improved safety is what is needed and additional patrols may not be the most effective manner to achieve improved safety on the lakes. Perhaps a coordinated effort with the Fox Waterway Agency, Lake County and state legislators making changes by regulatory means such as linking OUI's and DUI's or limiting cigarette style boats on the Chain of Lakes, would achieve greater safety. Forming a task force including the Sheriff's Office

and State's Attorney's Office was suggested.
