ORDINANCE OF NOVEMBER 16, 2010 AGENDA ITEM

AN ORDINANCE OF THE COUNTY OF LAKE, ILLINOIS, AUTHORIZING THE AMENDMENT OF ORDINANCE OF AUGUST 10, 2010, AGENDA ITEM 39: AN ORDINANCE AUTHORIZING THE ISSUANCE AND SALE OF \$20,000,000 WATER AND SEWER SYSTEM REVENUE BONDS, SERIES A OF 2010, AND PROVIDING THE TERMS OF AND SECURITY FOR PAYMENT THEREOF.

WHEREAS The County of Lake, Illinois (the "County"), owns and operates a combined waterworks and sewerage system (the "System" as more completely defined in the following text) under and in accordance with the provisions of Division 5-15 of the Counties Code of the State of Illinois (55 ILCS 5/1-1001 et seq.), as amended (the "Act"), and all laws supplementary thereto, including the Local Government Debt Reform Act, as amended, and the other Omnibus Bond Acts of the State of Illinois (collectively, the "Applicable Law"); and

WHEREAS the County Board of the County (the "County Board"), by an Ordinance enacted October 13, 1964 (as subsequently amended June 10, 1968, November 13, 1990, and June 24, 1993, and as supplemented by additional series ordinances) (the "Ordinance"), did authorize the acquisition and construction of the System in and for the County and did authorize the issuance of an Initial Series of Bonds, and did set forth the terms securing the bonds, including the power to issue Additional Bonds pursuant to Series Ordinances (defined in the Senior Lien Bond Ordinance); and

WHEREAS the County Board, by an Ordinance (the "Bond Ordinance") adopted on August 10, 2010, Agenda Item 39 as follows:

AN ORDINANCE AUTHORIZING THE ISSUANCE AND SALE OF \$20,000,000 WATER AND SEWER SYSTEM REVENUE BONDS, SERIES A OF 2010, AND PROVIDING THE TERMS OF AND SECURITY FOR PAYMENT THEREOF.

did authorize the County to issue \$20,000,000 Water and Sewer System Revenue Bonds, Series A of 2010 (the "Bonds") and the County did issue said Bonds on October 4, 2010; and

WHEREAS the Bond Ordinance indicates that the Bond proceeds are to be used "to improve and extend the System including, among other items, the Mill Creek WRF expansion, the Grainger LS 2nd force main, various water main replacements, the NEC PS 2nd force main, and the NEC pump station improvements, and including the acquisition of land or rights in land and all mechanical, electrical and other services necessary, useful or advisable to such work, and, incidental to such improvements and extensions, various costs of financing" (and further defines said acquisition, construction, services, and incidental expenses being referred to as the "Project"); and

WHEREAS due to unforeseen circumstances and project schedule changes between the time of adoption of the Bond Ordinance and the time of the issuance of the Bonds, certain County officials have determined that the proceeds of the Bonds should be used for other lawful projects to improve or extend the System within the County; and

WHEREAS the County Board does hereby determine that it is advisable and in the best interests of the County that the Bond proceeds be used to repair, refurbish, replace, and expand of several capital improvement projects throughout the System, including: expansion of the Mill Creek Water Reclamation Facility, the Grainger Lift Station 2nd Force Main, various Water Main replacements, the Northeast Central Pump Station 2nd Force Main, and the Northeast Central Pump Station improvements, the Portwine Road Lift Station 2nd Force Main, the Fox Lake Hills Water Tower & the Vernon Hills Water Tower refurbishment, the Diamond/Sylvan Lake Sewer diversion & the Diamond/Sylvan Lake Water Reclamation Facility abandonment, the Des Plaines River Water Reclamation Facility refurbishment, the New Century Town Filter Building & Clarifier refurbishment, the Teal Lane Force Main replacement, various Sanitary Sewer relining and replacements, the Southeast Interceptor refurbishment, the Maple Lane & Acorn Lane Lift Station improvement, the East Main Street Pump Station improvement, the Countryside Manor Water Tower & the Bradley Road Reservoir refurbishment, the Northeast Central Gravity Interceptor improvement and the Vernon Hills Water Pressure Booster improvements, including all mechanical, electrical, plumbing components and professional services (said acquisition, construction, services, and incidental expenses being the "Amended Project");

NOW THEREFORE BE IT ORDAINED by the County Board of The County of Lake, Illinois, as follows:

- Section 1. Incorporation of Preambles. The County Board hereby finds that all of the recitals contained in the preambles to this amendatory ordinance (the "Amendatory Ordinance") are true and correct and does incorporate them into this Amendatory Ordinance by this reference.
- Section 2. Applicable Law. This Amendatory Ordinance shall be construed under and governed by the laws of the State of Illinois.
- Section 3. Project Amendment. The County Board hereby finds and determines that it is necessary for and in the best interests of the County and the users of the System that the proceeds of the Bonds shall be used for purposes as defined by the Amended Project, and the County shall not be constrained in the use of the Bond proceeds to the purposes as defined by the Project, in the Bond Ordinance.
- Section 4. Superseder. All ordinances, resolutions or orders, or parts thereof, in conflict with the provisions of this Amendatory Ordinance are to the extent of such conflict hereby superseded.
- Section 5. Effective Date. This Amendatory Ordinance shall become effective immediately upon its passage.
