Presentation and annual update by the Lake County Coroner.

Presented by Orlando Portillo, Chief Deputy Coroner's Office. Mr. Portillo updated the committee on recent equipment changes that are vital to investigations and can identify contraband in a matter of hours instead of days or weeks. These results will still need to be sent out to a third party lab for confirmation. All drug related deaths should require an autopsy, to insure accurate reporting with regard to the death. Like the rest of the Country Lake County has seen an increase in heroin related deaths. There have been 8 deaths reported through April. The Lake County Coroner's Office has 5 full time deputy coroners on staff.
