Resolution authorizing a Collective Bargaining Agreement (CBA) between the Lake County Board, Lake County Health Department Board, and the International Union of Operating Engineers, Local 150, Health Department Maintenance Unit.

- This is a four-year agreement beginning on December 1, 2022 and lasting through November 30, 2026 and covers 8 total positions in the Health Department Maintenance Division.
- Wage Settlement as follows:
  - o Effective December 1, 2022: 3.25% across the board increase
  - o Effective December 1, 2023: 4% across the board increase
  - Effective December 1, 2024: 3.5% across the board increase with additional equity adjustment of 3% or 4% depending on position.
  - Effective December 1, 2025: same as non-represented employees of the County with a minimum increase of 2.5%. Additional equity adjustment of 1%.
- The County agrees to continue employee medical and dental insurance through the Midwest Operating Engineers Fund at no cost to the employee.
