The Health Department and Community Health Center has received a transformation grant through the Substance Abuse and Mental Health Services Administration (SAMHSA) to better care for veterans and their families. This program will focus especially on, but not limited to, those involved with the wars in Iraq and Afghanistan.*

**9. County Administrator's Report**

- **Presentation from the Health Department regarding animal control.**
- **Discussion regarding yard waste management and open burning.**

*Mark Pfister, Health Department, informed the committee of the law regarding animal kennel licensing. Kennels are licensed through the Illinois Department of Agriculture (IDOA) and inspected on a yearly basis. Lake County Animal Control does not have authority to inspect the facilities, however, if they have probable cause, they may obtain a search warrant to inspect the facility. The Muddy Paws kennel did not have a current license and gave up all rights to the remaining animals (2 cats and 4 dogs) to Lake County Animal Control. All of the animals are alive and are currently doing well. The committee further discussed animal welfare policies and procedures.*

*Phil Rovang and Barry Burton, County Administration, provided a presentation concerning yardwaste/landscape burning regulations from Lake County municipalities and surrounding counties. Mr. Michelini, Stevenson High School, informed the committee that the school is impacted by smoke coming from school neighbors burning leaves and yard waste. Mr. Michelini noted smoke covers athletic fields and enters the school via the building's air intake system. He presented letters and emails from several concerned parents and employees. After much discussion, the committee decided to have staff investigate a pilot program with Stevenson High School and bring recommendations to the committee.*
