Re: Proposed 2013 Unified Development Ordinance Text Amendments

Articles 10 and 11

On May 28 the Committee directed staff to prepare text amendments to Articles 10 and 11 of the Lake County Unified Development Ordinance (UDO), which pertain to subdivisions and school and park contributions. The proposed amendments relate to streamlining the administrative processes for subdivisions and eliminating inconsistencies in the ordinance. The draft amendments are included in Exhibit "A" attached to this report, and the following page includes a guide to the document. Staff will present a brief overview of the proposed amendments at the October 1 meeting.

While the Zoning Board of Appeals holds public hearings for zoning text amendments, the Planning, Building and Zoning Committee is responsible for conducting public hearings on amendments related to subdivisions (Article 10) and school and park contributions (Article 11), in accordance with state statute. At the conclusion of the discussion regarding the proposed amendments, the Committee will take action to schedule a public hearing to be held at the October 29, 2013 Committee meeting.
