UNIFIED DEVELOPMENT ORDINANCE

7.3 13-0606

Presentation of draft amendments to the Unified Development Ordinance (UDO) regarding expanding the zones in which the raising of chickens is allowed.

Presented by David Husemoller, Planning, Building and Development Department. Mr. Husemoller discussed the proposed amendments.

Sharon Gaughan, resident of Wildwood representing the Liberty Prairie Foundation, noted that local hen-raising often occurred without neighbors' knowledge, given the minimal noise associated with such activity. She also noted chickens' benefits including insect pest control and fresh eggs, and indicated she would like to establish a coop on her property.

Nan Huffman, Lake County resident, stated that the public has negative associations with

keeping chickens due to the operations on large chicken farms. Issues such as stench and disease would not factor into a small group of chickens on an individual parcel.

Following the public's comments, the Committee requested various changes to the draft ordinance regarding chicken terminology, and regarding a reduction in the size of the lot required for keeping chickens. The revised draft text will be brought back to the Committee for formal action at a later meeting.
