## 7.5 <u>10-1019</u>

Joint resolution authorizing an Intergovernmental Agreement with the Lake County Forest Preserve District (LCFPD) for utilization of Lake County records/cad/mobile systems.

- The Lake County Forest Preserve District as part of the Integrated Justice project has chosen to become a jurisdiction on the Lake County Sheriff's Office Records Management (VisionRMS), Computer Aided Dispatch (VisionCAD) and VisionMobile servers.
- Jurisdictions purchase their own server and client licenses to maintain the products used as well as maintain their own data on the servers. Data can be shared based upon rights each jurisdiction chooses to provide.
- There exists sufficient space on the servers to host the Lake County Forest Preserve District as a jurisdiction and this integration will prove beneficial to both parties.
- The Lake County Forest Preserve currently reimburses the County \$60,000 for dispatch services from the Lake County Sheriff's Office.
- The Lake County Forest Preserve District governing board has signed the IGA and awaits our resolution.

# 7.6 <u>10-0886</u>

Joint resolution establishing the Coroner's fees fund and authorizing a line item transfer and an emergency appropriation of FY2010 revenue and expenses of \$31,482 from the Coroner's general operating budget into the newly created Coroner's fees fund.

- Senate Bill 2529 revised Illinois Statute 55ILCS 5/4-7001 to require all fees collected under that section by the Coroner's office to be deposited into a special fund.
- Revenue collected in this fund may be used for electronic and forensic identification equipment and operating expenses of the Coroner's office.
- A line item transfer and an emergency appropriation of \$31,482 of FY2010 revenues and expenses from the Coroner's general operating budget to the newly created Coroner's Fees is proposed.

## 7.7 10-1083

Joint resolution for the continuation of the State's Attorney's Prosecutor-Based Victim Services grant program (agreement #210177) with \$61,127 in federal funds awarded

by the Illinois Criminal Justice Information Authority for the time period of October 1, 2010 through September 30, 2011.

- This is for a victim assistance grant renewal administered through the Illinois Criminal Justice Information Authority.
- Funding for this grant began in 1991 and has been renewed each year.
- Though funding allocated to the State of Illinois for distribution to Prosecutor Based Victim Services programs in FY2008 had been reduced by over 20%, the 2009 American Reinvestment and Recovery Act (ARRA) stimulus funding increased FY2009 funding by 17%, and this year's FY2010 amount increased 12% from 2009, from \$54,578 to \$61,127.
- This year our grant is changing focus from the previously under-served Hispanic victim population to the currently under-served sexual assault victim population.
- Of the \$61,127 in federal funds, \$54,629 is allocated to the grant-assigned Sexual Assault Victim Witness Counselor's salary: this dollar amount is consistent with last year's salary allocation. The 2010 increase (\$6,498) in federal funds are allocated to training and contractual printing: these expenses are necessary to assure that sexual assault victims receive specialized services and pertinent information early in the process.
- The \$54,629 for salary and \$6,498 for training and printed materials comprise the total award amount of \$61,127.
- The 20% required match, in the amount of \$15,282, consists of \$7,755 from the State's Attorney Asset Forfeiture Fund and \$7,528 in County contribution as budgeted in the State's Attorney's budget through grant management center 101-3311010.

#### 19th JUDICIAL CIRCUIT COURT

Joint resolution authorizing the acceptance of Grant Award #TI023106 from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Treatment and an emergency appropriation of \$208,333 for the Lake County Therapeutic Intensive Monitoring Court Service Enhancement project.

- Lake County has received a \$208,333 Adult Treatment Drug Court grant from the Substance Abuse and Mental Health Services Administration for the period September 30, 2010 - September 29, 2011 to enhance the Therapeutic and Intensive Monitoring (TIM) Court through the implementation of recovery coaching and post-treatment follow-up activities.
- The 19th Judicial Circuit will use the grant funds to contract with recovery coaches hired and trained by the Haymarket Center. Intensive case management services provided by the coaches will include two evidence-based practices: motivational interviewing and contingency management.
- There is no local match for this grant.
- Upon the successful completion of the first year, this grant is renewable in the amount of \$208,333 for two additional years
- This resolution authorizes the acceptance of the grant and appropriates the \$208,333 in new funding.
