**VAR-001153-2026:** On the petition of Marcin & Monika Szewczyk, record owners, who seek the following variations from the requirements of the Lake County Code and any other zoning relief as required:

1. Reduce the front street setback from 30 feet to 20.8 feet to alleviate the nonconforming status of an existing single-family dwelling.
2. Reduce the front street setback from 30 feet to 23.8 feet to accommodate an addition to the house.
3. Reduce the minimum side-yard setback from 19 feet to 9 feet to accommodate the incorporation of a detached garage and covered deck addition to the existing principal structure (single-family dwelling).

The subject property is located at 25960 W Hippler Rd, Barrington, IL and is approximately 1.91 acres.
