Approval of the Lake County Community Development Duplication of Benefits Policy

- Lake County administers multiple federal funding streams including Community Development Block Grant (CDBG) funds that can be allocated for disaster relief.
- The Robert T. Stafford Disaster Relief and Emergency Assistance Act (Stafford Act) requires that recipients of federal disaster recovery funding make certain that no "person, business concern or other entity" will receive duplicative assistance.
- The Duplication of Benefits (DOB) Policy outlines the policies and procedures the County and subrecipients shall follow to ensure DOB compliance.
