Liz Nelson, Opioid Coordinator, presented the Lake County Opioid Settlement Strategy Report prepared by Third Horizon.

Based on this report, Lake County developed a funding plan for program year 2025 (PY2025). The first-year funding will focus on the funding categories: harm reduction, case management and system navigation, and recovery services to decrease in fatal overdoses by five percent and non-fatal overdoses by ten percent. Funding for PY2025 will also focus on racial equity to give priority to projects that impact communities with the highest overdose rates in Lake County (Zion, Waukegan, North Chicago, Round Lake Area, Antioch).

This funding plan details a fair and transparent process with quarterly updates on the funding categories and progress on goals and key performance indicators, as well as, developing a process for ongoing community and stakeholder input.

Liz also outlined the scoring criteria geared toward community impact, program quality, and agency capacity where applications will score higher for targeting hot spot communities and black residents and a service design with an evidence-based strategy.

6.2 24-1318

Joint resolution approving the Lake County 2025-2026 Opioid Response Funding Plan.

• Lake County is receiving a direct distribution of settlement funds under the Illinois

Opioid Allocation Agreement and anticipates receiving approximately \$9 million no later than 2038.

- Lake County developed a Funding Plan detailing a fair and transparent process including formal and informal feedback from people with lived experience and community members.
- Program Year 2025 will be the first round of funding, and will focus investments in harm reduction, case management and system navigation, and recovery services.

Approval of the Lake County Opioid Settlement 2025-2026 Goals, Remediation Categories and Scoring Criteria.

- Program Year 2025 will be the first year Lake County solicits applications for Opioid Settlement Funds.

- Goals in the first year include a 5% decrease in fatal overdoses and a 10% decrease in non-fatal overdoses by April 2026.
