## 28. <u>12-0105</u>

Resolution authorizing a contract with Oracle Corporation, Chicago, IL for the purchase of a licensing software package for both current and additional operational and technical functionality within the BOSS software system in the amount of \$1,657,609.

- In 2003 Lake County entered into a contract with Oracle Corporation, Chicago, IL to provide licenses for the Oracle Software now known as BOSS.
- As part of the budgeting process for both 2012 and prior years, the County identified funding for additional software to implement Performance Management (employee evaluations), an enhanced educational module, an Inventory/Enterprise Asset Management (EAM) solution and a performance measurement tool.
- When approaching Oracle regarding these initiatives, Oracle provided a bundled software and support package which includes additional functionality including Business Intelligence (BI) for Financial, Procurement and Human Resources Analytics; Learning Management; Enterprise Asset Management (EAM); and the Hyperion solution for Public Sector Planning and Budgeting.
- The software and support along with necessary technology products has a cost to the County of \$1,657,609.
- The Purchasing Agent convened an ad hoc review group that approved bid exemption
  on the basis that the licensing for Oracle is proprietary and, as such, is a sole source
  purchase. In addition, the additional modules and software requested through this
  purchase have been designed by Oracle and provide functionality integrated with the
  County's existing system.
- Funding for licenses will occur over a three-year period through an Oracle Municipal Payment Plan. Total funding needed for FY12, including one-third of the license cost and one year of annual support cost, is \$759,203 of which \$403,000 was budgeted in the FY12 budget and \$356,203 was obtained from carryovers, CCIP reallocation, and CCIP unallocated balances. License funding for FY13 and FY14 will be included in the budget requests for those years out of CCIP and support costs will be included in the operating budgets requests.

#### 29. 12-0116

Resolution authorizing a contract with Exelon Energy, Kennett Square, PA, for Natural Gas Transportation and Management Services in an annual estimated amount of \$373,000.

- Lake County desires to enter into a contract for Natural Gas and Transportation Management Services for Lake County.
- Lake County extended invitations for bid to nine potential service providers and received four responses.
- Based on the evaluation criteria set forth in the Invitation for Bid, Exelon Energy,
   Kennett Square, PA is the lowest responsive and responsible bidder for Lake County.
- This contract will cost the County an estimated annual amount of \$373,000.

#### 30. 12-0113

Resolution authorizing a contract with Christopher B. Burke Engineering Ltd. (CBBEL), Rosemont, IL to provide construction documents and part time construction observation for a new parking lot at the south west corner of Water Street and Martin Luther King Drive in the amount of \$101,300.

- In 2004 and 2005 the County purchased five parcels of land on the south west corner
  of Martin Luther King Jr. St. and Water St. in downtown Waukegan, with the intent of
  constructing a future parking lot
- Lake County has a need for additional parking spaces to accommodate jurors, the public, and County Employees.
- To accommodate parking, the County is currently in a month to month lease with the City of Waukegan for the parking garage at the northeast corner of County and W. Clayton Streets.
- A new parking lot will provide a long term, permanent solution for additional parking for jurors and employees of the Sheriff's Office during shift change.
- Funding for the construction of a new parking lot was approved as part of the 2012 CIP new program request process, and incorporated into the Adopted 2012 Budget.
- The County is proposing construction of a 170 stall surface parking lot with associated access control, stormwater detention, and landscaping, at the County owned property.
- CBBEL has completed a Phase I engineering study of the site, the County has a long standing, working relationship with the firm, and has selected them to complete the project in compliance with the Local Government Professional Services Selection Act.

#### 31. 12-0131

Joint resolution authorizing an on the job training agreement with CVS Pharmacy, Inc. located in Antioch in the amount of \$8,000.

- The Lake County Workforce Development Department was awarded a grant to fund on the job training.
- The grant funds 90% of the wages paid to dislocated workers while they are being trained.
- The agreement will be with CVS Pharmacy, Inc., a pharmacy located in Antioch, Illinois.
- The new hire, an unemployed Lake County Resident will be trained as a Pharmacy Technician and will be paid \$10 per hour.

 The cost of training is \$7,200 (Workforce Development) plus \$800 (employer) for a total cost of \$8,000.

# **32. 12-0132**

Joint resolution authorizing an on the job training agreement with Allan-Odis, Inc. located in Zion in the amount of \$25,600.

- The Lake County Workforce Development Department was awarded a grant to fund on the job training.
- The grant funds 90% of the wages paid to dislocated workers while they are being trained.
- The agreement will be with Allan-Odis, Inc., a commercial building and condominium management company located in Zion, Illinois.
- The new hires, both Lake County residents, will be trained as project managers and paid \$16 per hour.
- The cost of training is \$23,040 (Workforce Development) plus \$2,560 (employer) for a total cost of \$25,600.

#### 33. 12-0134

Resolution confirming that floods from presidentially declared disasters of 2008 meet the Urgent Need National Objective for the State of Illinois administered Community Development Block Grant (CDBG) "Midwest" Disaster Recovery Program.

- The federal Supplemental Appropriations Act of 2008 (Public Law 110-252-No.1)
  appropriated funds to the CDBG program for specific recovery activities related to 2008
  presidentially declared disasters and established the CDBG "Midwest" Disaster
  Recovery Program, administered by the State of Illinois Department of Commerce &
  Economic Opportunity (DCEO).
- Following the declaration in 2008, DCEO identified a total of 45 eligible FEMA approved recovery projects for 10 units of local government within Lake County; no projects from unincorporated Lake County were eligible.
- In 2010 the County Board authorized the Community Development Division to compile
  materials from the eligible local government units into one omnibus program application
  and serve as the single point-of-contact on behalf of the units of local government.
- The recovery funding applied for is \$510,732.81.
- In order to comply with federal CDBG regulations, DCEO has requested that recipient
  jurisdictions pass a resolution confirming that the floods of 2008 meet the Urgent Need
  National Objective and was a serious and immediate threat to the health, safety, and/or
  welfare of the community with no identifiable alternative funding sources.

Joint resolution authorizing the execution of various professional service agreements for psychological services in accordance with the attached rates for the Lake County Psychological Services Division of the Nineteenth Judicial Circuit Court in the estimated amounts of \$180,000.

- Lake County desires to enter into contracts for psychological services for the Lake County Psychological Services Division of the Nineteenth Judicial Circuit Court.
- Lake County extended requests to 32 potential service providers and received 11

proposals.

- An ad hoc review committee reviewed all proposals and will select qualified providers in accordance with the service rates established herein.
- This contract will cost the County an estimated annual amount of \$180,000.

#### **35. 12-0073**

Joint resolution authorizing Robert Skidmore, Lake County Treasurer, to withdraw monies from the Bond Series A of 2010 Construction Account to pay construction cost Items.

- The County issued bonds in October 2010 in the amount of \$20,000,000 to construct various water and sewer system improvements.
- Pursuant to the County Bond Ordinance, the County Board must approve disbursements of bond proceeds from the construction account.
- This withdrawal represents Payout No. 15 and satisfies several invoices related to various projects in the amount of \$1,326,406.36.
- The remaining balance available, after authorization of this payment, will be \$5,304,498.61.

#### **36. 12-0091**

Joint resolution authorizing execution of a contract in the amount of \$72,009 with Water Well Solutions Illinois Division, LLC of Lake Villa, for the Water Well Closure and Abandonment Project

- The Vernon Hills, Wildwood and Countryside Manor water systems receive their water from CLCJAWA; however, these systems have back-up wells that have been in place since Lake Michigan water delivery began in 1990.
- It has been determined to be more cost effective to discontinue and abandon the wells because the back-up wells are in need of significant service and repair and have not been utilized since the 1990's.
- The County received bids from four contractors for this work.
- Award of this contract is recommended to the lowest responsive, responsible bidder, Water Well Solutions Illinois Division, LLC in the amount of \$ 72,009.

#### 37. 12-0083

Joint resolution appropriating \$655,000 of Matching Tax funds for the installation of a new steel pile retaining wall on the east side of Lewis Avenue, 2100 feet north of Illinois Route 173, along with a culvert liner and designated as Section 11-00000-07-GM.

- 2012 Retaining Wall Maintenance: Appropriation.
- The replacement of this retaining wall and culvert liner is included in the FY2012 program.

 Before a project letting can be held, an appropriation of \$655,000 of Matching Tax Funds is necessary.

### 38. 12-0084

Joint resolution authorizing a supplemental appropriation of \$85,000 and execution of a supplemental agreement with Christopher B. Burke Engineering, Inc., Rosemont, Illinois, for the provision of additional Phase II professional engineering services for Wadsworth Road at Green Bay Road and designated as Section 03-00033-12-CH.

- Wadsworth Road at Green Bay Road Intersection Improvement: Supplemental Consultant Phase II Agreement and Supplemental Appropriation.
- Additional Phase II engineering services are necessitated for the redesign of the signals' interconnect system from wireless to a buried cable system for Wadsworth Road at Green Bay Road.
- This resolution authorizes the execution of a supplemental agreement with Christopher B. Burke Engineering, Inc., Rosemont, Illinois, at a cost of \$71,329.93.
- This resolution appropriates \$85,000 of Motor Fuel Tax funds for these services.

#### 39. 12-0085

Joint resolution authorizing the execution of Amendment 1 to the agreement for the use of federal highway funds between the State of Illinois/Illinois Department of Transportation (IDOT) and Lake County for the improvements to Wadsworth Road at Green Bay Road designated as Section 03-00033-12-CH.

- Wadsworth Road at Green Bay Road Intersection Improvement, Phase II
   Supplemental: IDOT Agreement.
- The County has been allocated federal Congestion Mitigation and Air Quality (CMAQ) funds to widen and reconstruct this section of Wadsworth Road and Green Bay Road and IDOT administers all federal highway funds.
- The Phase II design engineering scope of work is being expanded to provide for redesigning the signals' interconnect system from wireless to a buried cable system not anticipated in the original design.
- This agreement allows for the County to receive 80% reimbursement for the cost of this Amendment 1.

#### **40**. <u>12-0098</u>

Joint resolution authorizing the execution of Amendment 1 to the agreement between Lake County and the City of Waukegan for the improvements to Delany Road so as to accommodate the inclusion of the City of Waukegan's watermain relocation costs as part of Section 00-00093-17-WR.

- Delany Road Improvement (Sunset Avenue to York House Road); City of Waukegan Agreement: Amendment 1.
- The County has awarded a contract to widen and reconstruct Delany Road, from Sunset Avenue northerly to York House Road.
- On August 11, 2009, the Lake County Board approved an agreement with the City of Waukegan for their portion of the cost of the improvement, but which agreement did not include the costs of the watermain relocation to be undertaken by the City independently.

- The City has had difficulty in acquiring the necessary easements for the watermain relocation and funding the work.
- Amendment No. 1 is to ensure that construction of the County's Delany Road improvement can move forward in a way that benefits both parties.
- The County and the City will swap portions of roads that better meet their roadway system functions: the County receives Lewis Avenue (Sunset Avenue to York House Road) and the City receives the dead end portion of York House Road, Delany Road to Canadian Pacific Rail Road (CP RR).
- The County will save funds from the programmed resurfacing of York House Road (CP RR tracks to Delany Road), while the City will save the amount of the watermain costs.
- The watermain work will be added as Change Order No. 3 to the County contract in the amount of approximately \$1M, and this resolution resets the change order base so future change orders can be processed as originally required.

- County Speed Zone Ordinance: Bonner Road in Wauconda Township.
- Ordinance is required to establish speed zones.
- The necessary speed studies have been undertaken.
- This will extend the 30 M.P.H. zone west through the revised school zone for the Robert Crown Elementary School.

#### 44. 12-0046

Ordinance providing for the establishment of an altered speed zone for 45 M.P.H. on currently posted 50 M.P.H Darrell Road, from a point 1,000 feet north of Lake View Circle (North) to a point 2,870 feet north of Burnett Road, located in Wauconda Township, in conformity with Chapter 625 - Section 5/11-604 of the Illinois Compiled Statutes.

- County Speed Zone Ordinance: Darrell Road in Wauconda Township.
- · Ordinance is required to establish speed zones.
- The necessary speed studies have been undertaken.

- County Speed Zone Ordinance: Sand Lake Road in Lake Villa Township.
- Ordinance is required to establish speed zones.
- The necessary speed studies have been undertaken.
- This will extend the 30 M.P.H. zone through the revised school zone for the B. J. Hooper Elementary School.

#### 46. 12-0136

Joint resolution authorizing a professional services agreement with AECOM Technical Services, Inc. in the amount of \$132,480 for construction observation services for the Vernon Hills Water Reclamation Facility Miscellaneous Improvements Project.

- The Vernon Hills water reclamation facility is a major wastewater treatment plant that
  provides services for the Village of Vernon Hills and unincorporated portions of
  southeast central Lake County.
- The plant has major equipment that has reached the end of its useful life and now requires replacement of two effluent filters, replacement of three sludge pumps, and repair to two clarifiers, along with other miscellaneous building and equipment improvements and repairs.
- The County awarded a construction contract for this project to Concord Construction Services, Inc. in the amount of \$2,069,800.
- Construction observation services from a professional engineering firm are required.
- The County has received prior satisfactory services of this type from AECOM Technical

Services, Inc., Sheboygan, Wisconsin.

 This resolution authorizes an agreement for professional services with AECOM Technical Services, Inc. in the amount of \$132,480.

## **47**. <u>12-0119</u>

Joint resolution authorizing a contract for bridge deck repairs and resurfacing at the Everett Road and Deerfield Road bridges, over the I-94 Tollway, to Herlihy Mid-Continent Company, Romeoville, Illinois, in the amount of \$485,366 and designated as Section 11-00999-20-RS.

- Everett Road and Deerfield Road at I-94 Tollway: Contract Award.
- Repairs to the Everett Road and Deerfield Road bridges, over the I-94 Tollway, are included in the County's 2012 Highway Improvement Program.
- A total of 6 bids were received, and the lowest responsible bidder is Herlihy Mid-Continent Company, Romeoville, Illinois, in the amount of \$485,366.

#### 48. 12-0126

Joint resolution appropriating \$135,000 of Motor Fuel Tax funds to provide for crack sealing of asphalt and concrete pavement, where necessary, on various County highways and designated as Section 12-00000-07-GM.

- 2012 Crack Sealing: Appropriation
- Each year crack sealing is done to County highways that have recently been resurfaced.
- Before a project letting can be held, an appropriation of \$135,000 of Motor Fuel Tax funds is necessary.

#### 49. 12-0127

Joint resolution appropriating \$50,000 of Motor Fuel Tax funds for concrete pavement patching, where necessary, on various County highways and designated as Section 12-00000-08-GM.

- 2012 Concrete Pavement Patching: Appropriation.
- Each year, the County undertakes patching of its concrete pavements to preserve surface quality, including repairing damaged manholes, catch basins, curbs, and gutters.
- This patching and repair is done on isolated sections of pavements that are not listed in the Five-Year Program for resurfacings/rehabilitation/reconstruction, but identified by the Pavement Management System as needing repair.
- Before a letting can be held, an appropriation of \$50,000 of Motor Fuel Tax funds is necessary.

## 50. 12-0128

Joint resolution appropriating \$520,000 of Matching Tax funds and \$630,000 of Motor Fuel Tax funds for annual bituminous maintenance of various roads and bike paths on the County highway system and designated as Section 12-00000-09-GM.

• 2012 Bituminous Maintenance: Appropriation.

- Each year the County undertakes maintenance of its bituminous pavement, bituminous shoulders, and bike path pavement to preserve the surface quality.
- Before a project letting can be held, an appropriation of \$520,000 of Matching Tax funds and \$630,000 of Motor Fuel Tax funds is necessary.

Joint resolution authorizing an emergency appropriation in the amount of \$55,520 in the Stormwater Management Commission's Miscellaneous Contractual Services for the purchase of Wetland Mitigation Credits at the Atkinson Road Wetland Mitigation Bank within the North Branch of the Chicago River Watershed.

- The SMC Wetland restoration Fund (WRF) collects fees from wetland impacts into a deferred revenue account for each of the four major watersheds in the country.
- Once the fund reached a threshold value or credits become available within a
  watershed wetland bank, the WRF policies mandate a financial process, which requires
  an emergency appropriation to allocate funds for expenditure.
- On December 1, 2011, SMC approved the expenditure of \$55,520 to purchase 0.694
  acre of wetland mitigation credit at the Atkinson Road Wetland Mitigation Bank (North
  Branch of the Chicago River) in order to replace 0.30-acre of isolated wetlands lost due
  to development impacts.

## **52. 12-0114**

Joint resolution authorizing approval of Amendment #2 to an Inter-Governmental Agreement (IGA) between the County of Lake and the Lake County Stormwater Management Commission (SMC) for the construction of a partial green roof at the Lake County Central Permit Facility in Libertyville, Illinois. Lake County will be reimbursed up to \$187,032 by SMC from a grant received from the U.S. Environmental Protection Agency for installation of a green roof.

- Lake County entered into an IGA with SMC in June of 2008, amended in February 2011 for up to \$183,721 of grant funded reimbursement for the construction of a green roof at the Lake County Central Permit Facility.
- Additional funding has become available through the existing State and Tribal
  Assistance Grant (STAG) and SMC has recommended re-allocation of these funds to
  provide additional reimbursement of the green roof project at the Central Permit
  Facility.
- Amendment #2 will increase the grant amount by \$3,311 for a total funding of \$187,032
  of US EPA STAG funds to be reimbursed to the County for the installation of the green
  roof at the Central Permit Facility.
- The additional grant funding increases the STAG cost-share for this grant from 57% to 58% and does not otherwise change the funding agreement between SMC and the US EPA.

- This resolution also authorizes the subsequent transfer by the County to the Illinois Department of Transportation of the easements along Illinois Rte 176.
