Subject: Bleck Engineering Co. General Engineering Services Agreement: Request for Additional Funding

ACTION REQUESTED: Approval

Bleck Engineering Co. is currently performing various engineering and related tasks on sixteen projects (see list below) for SMC under our Professional Services Agreement (Agreement) approved on April 7, 2022. The Agreement is for a not-to-exceed amount of \$689,260.55 (T&M basis) through April 6, 2025. The current projects total \$875,295.55, leaving a balance of \$186,035.00.

Staff requests approval to expand Bleck's current Service Requests to #16. The not-to-exceed total costs for #16 are \$222,215.00. SR #16 will be reimbursed by FEMA grant engineering expenses.

Your approval is requested to increase the not-to-exceed amount in the Agreement to \$875,295.55 to cover the engineering project costs through SR #16.
