Executive Summary

Program Title: Lake County Court Improvement Program: Familial Abuse/Neglect Child Victims

Total Funding Request: \$196,336

Program Length: 17-month project starting in May 2010.

Lake County State's Attorney's Office proposes a program to strengthen the infrastructure of child protection cases in Lake County Courts. This pilot program provides **specialized legal advocacy** for child victims of abuse/neglect and non-offending family members. A specially trained senior prosecutor will be assigned and housed at the Lake County Children's Advocacy Center. This program position will facilitate operations in coordination with the newly-formed Lake County Sexual Assault Coordinating Council. Through program and Council's **coordination** with DCFS and the three Court Systems that are involved in family-related issues, child victims of sexual abuse will have **improved outcomes** through the available court protective services.

This program, which will be implemented in the high-caseload 19th Judicial Circuit, will provide long term benefit to other Illinois counties and court jurisdictions: it can be **replicated** in underserved downstate areas of Illinois where funding restrictions and low caseloads restrict those areas from implementation of a unified family court system. Using this program's **unified court coordination** and **integrated protocols** is a way of ensuring an infrastructure and coordination with the victim at the center of concern.

The program will serve 425 **child victims of abuse/neglect** for front-end **screening and interagency coordination**. From that population, approximately 50 victims of particularly heinous or complicated cases of abuse/neglect will receive specialized **coordinated advocacy** services in court proceedings.
