## 17 <u>19-1</u>217

Joint resolution authorizing the purchase of Solacom 9-1-1 Guardian equipment and professional services from Comtech Solacom Technologies, Gatineau, Quebec, Canada, in an estimated total amount of \$146,766.

- The Emergency Telephone System Board (ETSB) owns and manages a geo-diverse Solacom NG9-1-1 capable system installed at Lake Zurich and Lake County Sheriff Dispatch for the processing of 9-1-1 emergency calls since 2013.
- In order to maintain the reliability and high availability for successful processing of 9

   1-1 emergency calls using the Solacom 9-1-1 system, a refresh and replacement of the 9-1-1 servers, workstations, and associated hardware is recommended about every five years.
- Funding for the 9-1-1 system is provided by Lake County ETSB's collection of 9-1-1 fees that State law applies to land lines and cell phone bills.
- These revenues are programmed by the Lake County ETSB, and Lake County Government is the ETSB's fiduciary agent.
- In accordance with Article Six, Section 102 of the Lake County Purchasing
  Ordinance, the Purchasing Agent approved a bid exemption on the basis that there
  is only one source for the required goods, service, or construction item, and there

exists a long standing, successful relationship for software maintenance and support services. The knowledge gained through this relationship adds value integral to the services provided for these services.

#### 18 19-1218

Joint resolution authorizing the purchase of Tellus Aware, Tellus Unify Computer Aided Dispatch (CAD) to CAD interface software, and professional services from Tellus Safety Solutions LLC, Bountiful, Utah, in an estimated total amount of \$338,638.

- The Emergency Telephone System Board (ETSB) owns and manages a Tellus CAD interoperability solution that connects nine individual CAD systems and interfaces with Lake County Traffic Management for data sharing and situational awareness of 130 public safety agencies since 2012.
- ETSB and partner agencies have the need to upgrade the existing Tellus software
  platform to utilize advanced features and patented programming for a better user
  experience including successful migration to a full CAD to CAD interoperability
  solution.
- Funding for the 9-1-1 system is provided by ETSB's collection of 9-1-1 fees that State law applies to land lines and cell phone bills.
- These revenues are programmed by the Lake County ETSB, and Lake County Government is the ETSB's fiduciary agent.
- In accordance with Article Six, Section 102 of the Lake County Purchasing
  Ordinance, the Purchasing Agent approved bid exemption on the basis that there
  is only one source for the required goods, service, or construction item, and there
  exists a long standing, successful relationship for software maintenance and
  support services, and the knowledge gained through this relationship adds value

## 25 19-1266

Joint resolution accepting the Illinois Department of Public Health grant and authorizing an emergency appropriation in the amount of \$60,000 for the Immunization Elimination of Disparities program.

- The \$60,000 Illinois Department of Public Health grant will be used to support in-reach and outreach efforts in low-income areas, and to offset existing staff salary and benefit costs.
- The \$60,000 in additional grant funding has not been previously appropriated because the grant resources were secured after the County's adoption of the Fiscal Year 2019 budget.

## **27 19-1207**

Ordinance prohibiting the use of groundwater as a potable water supply by the installation or use of potable water supply wells or by any other method, related to an area in and around a closed landfill.

- A closed landfill exists on the site in question and ongoing remediation and testing have demonstrated that the groundwater in the area exceeds Illinois Class I standards for some parameters.
- The property owner is requesting that the County enact an ordinance to prohibit the
  use of groundwater from water wells as a potable source of water in designated
  areas around the closed landfill site in order to allow for development of these
  properties without further environmental remediation.
- The owner has secured similar ordinances from other neighboring jurisdictions.
- There are no current users of potable water wells in this designated area, and the Lake County Health Department has determined that new water wells would not be permitted in the area due to required setbacks to the closed landfill, and due to the proximity and availability of community (public) water in the area.
- The following County Departments have reviewed and concur with approval of the ordinance restricting use of potable groundwater in the designated area: Health, Planning, Building and Development, and Public Works.

## 28 <u>19-1056</u>

Resolution permitting the transfer of ongoing affordable housing-related commitments from Northpointe Resources, Inc. to Aspire of Illinois.

- Lake County has provided affordable housing grants for the development of group homes for Northpointe Resources' clients with intellectual disabilities.
- To leverage economies of scale that better serve its clients, Northpoint Resources,
   Inc. will transfer its assets, employees and programs to Aspire of Illinois, a

long-standing Illinois not-for-profit corporation serving Northpoint Resources' target population.

## 29 <u>19-1320</u>

Joint resolution accepting the Illinois Department of Commerce and Economic Opportunity (DCEO) Workforce Innovation and Opportunity Act (WIOA) Program Year (PY) 2019 formula grant and modification to WIOA PY 2018 grant authorizing a decrease in the budgeted appropriation in the amount of \$638,098 for the Lake County Workforce Development Department.

- The WIOA formula grant funds for the PY 2019 beginning July 1, 2019 have been allocated to Lake County and are being decreased by \$684,273 over the PY 2018 allocation, for a total grant of \$4,576,994. The WIOA PY 2019 formula grant has a grant life from July 1, 2019 through June 30, 2021.
- The WIOA formula grant funds for PY 2018 modification increases the grant by \$46,175. The WIOA PY 2018 formula grant has a grant life from July 1, 2018 through June 30, 2020.
- The WIOA formula grants include funding for programs serving adults, dislocated workers, incumbent workers, and youth.

## 30 <u>19-1223</u>

Ordinance providing for the establishment of an altered speed zone for 25 miles per hour (MPH), currently unposted 30 MPH, on Sunnyview Road, Fairhill Road, Bell Lane and Greenacres Drive located in Libertyville Township.

- The speed study was requested by the Libertyville Township Highway Commissioner.
- The necessary speed studies have been undertaken and an ordinance is required to establish speed zones.

### 31 19-1212

Joint resolution authorizing a contract with Path Construction Company, Arlington Heights, Illinois, in the amount of \$117,140 for replacing bridge expansion joints on Lake County maintained bridges, appropriating \$141,000 of County Bridge funds.

- This project also includes miscellaneous concrete repair work on the Washington Street and Deerfield Road bridges.
- A total of four bids were received, ranging from \$117,140 to \$224,695, and the lowest responsible bidder is Path Construction Company in the amount of \$117,140.
- This improvement is included in the highway improvement program and is designated as Section 19-00999-63-BR.

#### 32 <u>19-1214</u>

Joint resolution authorizing a contract with Campanella and Sons, Inc., Wadsworth, Illinois, in the amount of \$390,892.51 for culvert repair and guardrail replacement on Kilbourne Road, and appropriating \$470,000 of County Bridge Tax funds.

- A culvert installation on Kilbourne Road needs repair, and the existing guardrail at the culvert needs replacement.
- There was a public call for bids and a total of two bids were received, ranging from \$390,892.51 to \$574,108.71. The lowest responsible bidder is Campanella and Sons, Inc. in the amount of \$390,892.51.
- This replacement is included in the highway improvement program with construction planned in 2019 and is designated as Section 18-00094-03-BR.

#### 33 19-1216

Joint resolution authorizing a contract with H and H Electric Company, Franklin Park, Illinois, in the amount of \$284,578.70 for upgrades and expansion of the Intelligent Transportation System (ITS) PASSAGE Network and appropriating \$342,000 of 1/4% Sales Tax for Transportation funds.

- This work will connect new traffic signal controllers and expand the ITS communication network, including the installation of full-actuated controllers and layer II switches.
- A total of two bids were received, ranging from \$284,578.70 to \$302,534 and the lowest responsible bidder is H and H Electric Company in the amount of \$284,578.70.
- This improvement is included in the highway improvement program and is designated as Section 19-00999-64-TL.

Joint resolution appropriating \$38,800 (\$9,700 annually) of Matching Tax funds for four years of maintenance service for the Lake County Division of Transportation (LCDOT) Sign Inventory System.

- LCDOT purchased a new Sign Inventory System from 3M Company, St. Paul, Minnesota, in 2016.
- Year one maintenance was included in the original software purchase price and the agreement with 3M Company provides a total of five years of maintenance.

## 35 <u>19-1222</u>

Joint resolution appropriating \$30,000 of ¼% Sales Tax for Transportation funds for cellular service to communicate with various Lake County Division of Transportation (LCDOT) field assets, including traffic signals, cameras, pavement sensors, and snow and ice equipment and integration to Lake County PASSAGE.

- Lake County's PASSAGE System gathers data from traffic signals, counters, pavement sensors, cameras, and snowplows to manage traffic and provide the public with this information to make an informed decision when traveling.
- This project is included in the highway improvement program and is designated as Section 19-00000-18-GM.

## 36 <u>19-1225</u>

Joint resolution appropriating \$760,100 of Motor Fuel Tax funds for maintaining streets and highways, including utility services, under the applicable Illinois Highway Code, from December 1, 2019, to November 30, 2020, and \$200,000 of Matching Tax funds.

- In order to perform routine and necessary highway maintenance, the Division of Transportation must purchase Patrol One general maintenance materials and services.
- Patrol One general maintenance materials and services may include, but not be limited to, supplies such as paint, signposts, shoulder aggregate, and deicing materials, as well as utility services and repairs.
- This project is included in the highway improvement program, and is designated as Section 20-00000-00-GM.

## 37 <u>19-1226</u>

Joint resolution appropriating \$75,000 of County Bridge Tax funds for fiscal year (FY) 2019 engineering services, water quality monitoring services, and materials needed to meet the requirements of the Illinois Environmental Protection Agency (IEPA) General National Pollutant Discharge Elimination System (NPDES) ILR40 Permit for Lake County.

- Lake County is a municipal separate storm sewer system (MS4) community that is required to comply with the IEPA General NPDES ILR40 Permit that became effective on March 1, 2016.
- Permit requirements include new program enhancements, implementation of Best Management Practices, and water quality monitoring activities that will require the use of engineering and miscellaneous services, contract services, and materials, and is designated as Section 19-00000-19-GM.

Joint resolution authorizing an agreement for professional engineering services with Infrastructure Management Services (IMS), Tempe, Arizona, at a maximum cost of \$80,000, for the annual pavement testing services, and associated components, appropriating \$100,000 of Matching Tax funds.

- The County approved an agreement for professional engineering services with IMS in 1986 to implement a pavement management system.
- IMS was the original supplier of said database within the County's Automated Repair Guidance System (Argus).
- The pavement data in the system is updated on a yearly basis; it utilizes information collected and uses dynamic load testing and laser testing procedures.
- Approximately 25 percent of the county highway system is retested each year.
- Information from the pavement management system is used to generate recommended resurfacing projects for the next five years.
- In accordance with the Local Government Professional Services Selection Act, the recommended firm is IMS at a cost of services of \$80,000.
- This project is included in the highway improvement program and is designated as Section 19-00219-00-ES.

## 39 <u>19-1220</u>

Joint resolution authorizing an intergovernmental agreement with the Chicago Metropolitan Agency for Planning (CMAP) for the receipt of \$170,332.95 in funding to provide transportation planning staff assistance for the Lake County Council of Mayors (LCCOM).

- Planning liaison funds are distributed yearly from the Federal Highway Administration to CMAP through the Illinois Department of Transportation.
- These funds help support transportation planning provided by the Lake County Division of Transportation's (LCDOT) staff and the LCCOM.
- Among other activities, LCDOT staff will continue to be the communication link between CMAP and the LCCOM; regularly attend all CMAP boards, committees, and other relevant meetings; support the development and implementation of CMAP programs such as the Local Technical Assistance program; and provide technical and administrative support for the LCCOM related to the development, monitoring, and management of its federally funded transportation projects.
- In State Fiscal Year 2020, which begins July 1, 2019, the allocation to LCDOT will be \$170,332.95 to cover the workload that CMAP describes in its agreement.

- There is a need to identify a firm to provide a software solution for inmate commissary ordering, accounting and a delivery solution for the Lake County Jail.

#### 54 19-1208

Ordinance amending the Lake County Code of Ordinances Chapter 172 - Animals.

• The proposed revisions to 172.12 (B) contain requirements when the owner of a dog that has been declared animal-aggressive (when it has killed or seriously injured another owned animal) wants to give away or sell the dog or move to another jurisdiction.

- The proposed revisions would require an owner to notify Animal Care and Control prior to transferring custody of the dog so that a disposition letter can be provided to the new owner identifying the responsibilities needed to meet requirements.
- The proposed revisions would also require an owner to notify Animal Care and Control in both the jurisdiction to which he or she is moving, and the jurisdiction he or she is leaving. These revisions are modeled after similar requirements in the Illinois Animal Control Act for an owner of a dog that has been declared vicious (when it has killed or seriously injured a person).
- The proposed revisions to Section 172.15 are to discourage irresponsible breeding of dogs and cats.
- The Illinois Department of Agriculture (IDOA) licenses and regulates the breeding of dogs and cats, but only when the breeder has more than five breeding female animals.
- In chapter 172, the current pet limit restriction for residences is four dogs and four cats; however, it only applies to pets older than 6 months.
- In unincorporated Lake County, zoning and property use restrictions prohibit "regular" use of a property for breeding and selling pets, but that standard is difficult to establish and prove. Thus, the existing regulations leave a gap in regulating and discouraging irresponsible "backyard breeding."
  - The proposed revisions provide enforcement authority against irresponsible breeders, specifically those that maintain and treat their animals poorly.
  - The proposed revisions state that if a person is cited by an Animal Control Officer for failing to properly care for their animals (such as poor conditions, lack of food/water/shelter, failure to provide vet care, or cruelty), and the Officer finds that the person's animal has offspring present (i.e., is breeding them), the exemption for dogs or cats six months or younger would no longer apply, and all animals would be counted toward the pet limit.
  - In addition to the care/treatment violations, the person could be cited for violating the pet limit for each dog or cat above the limit. The person could be cited a \$100 fine per dog or cat, including those six months or younger, for violating the pet limit. Animal Care and Control would receive and pursue these cases on a complaint-driven basis.

Joint resolution authorizing a contract with Derive, Sanford, Florida, for the purchase of idle reduction technology for Lake County in the amount of \$34,713.

- During Lake County's Fiscal Year (FY) 2019 budget process, a New Program Request (NPR) was approved for the purchase of idle reduction technology.
- Idle reduction software is being installed on 87 county fleet vehicles in FY2019, which will result in an estimated six percent reduction in fuel usage and carbon emissions per vehicle. This will translate to an estimated \$60,000 per year savings in fuel costs based on current gasoline prices.

#### 58 19-1244

Ordinance approving an agreement with the Central Lake County Joint Action Water Agency (CLCJAWA) and establishing the payment plan for \$8,030,400 in connection fees for the Grandwood Park and Fox Lake Hills water system customers to be paid over a 30-year period.

- The County operates the Grandwood Park water system with 2,237 customers and the Fox Lake Hills water system with 631 customers. Both systems switched from wells to Lake Michigan water supplied by CLCJAWA in early 2019.
- The direct cost of constructing the new CLCJAWA distribution system is funded through the 20-year Special Service Area 16 tax levy.
- A separate connection fee of \$2,800 per property equivalent is also required. The
  money will be collected through a surcharge fee for customers in these two
  systems. The collected funds will be paid to CLCJAWA annually over a 30-year
  period with no interest applied.
- The ordinance establishes the annual repayment plan to CLCJAWA. The annual payments are graduated over the 30-year period to allow the option to ease into the surcharge program. However, staff recommends establishing a constant customer rate for the 30-year period to be consistent with how other surcharge fees are collected and to avoid confusion during future rate periods.
- Rate options have been established and will be presented.

#### 59 19-1311

Ordinance amending water and sewer related rates for certain Lake County systems.

- Chapter 51 of the Lake County Code of Ordinances establishes all water and sewer user rates, connection fees and additional charges for use of the County's water and sewer systems.
- The Ordinance is revised periodically to modify rates and fees, as necessary.
- Staff has worked with Burns and McDonnell, Inc. to complete a water and sewer
  rate and connection fee study to ensure that the County is maintaining and
  generating sufficient funds for operations, maintenance, depreciation, debt service
  and re-capitalization of assets.
- The amended Ordinance modifies several water and sewer rates and connection fees. Specific rates and fees are established for Fiscal Year 2020. Percentage increases are also identified for future fiscal years, but the county Board can modify the rates during the annual updates to the ordinance.
- The minimum retail water bill is replaced with a domestic meter service charge that increases by meter size.

- The water rate differential between the low use and highest use block rate was increased to 10 percent to support conservation.
- Notice will be provided to the County's municipal partners impacted by the changes to Chapter 51 of the Lake County Code of Ordinances that will become effective December 1, 2019.

Joint resolution authorizing an emergency appropriation for the Lake County Flood Hazard Mitigation Project by the Stormwater Management Commission (SMC) in the amount of \$3,845,091 and funded by the Illinois Department of Natural Resources, Office of Water Resources, (IDNR-OWR) Flood Mitigation program.

- SMC has authorized an agreement with the IDNR-OWR for a grant (Contract Number OWR-371) for the buyout of 12 flood-prone properties throughout Lake County, Illinois.
- Properties are designated as Federal Emergency Management Agenda (FEMA)
   "Severe Repetitive Loss" (SRL) and "Repetitive Loss" (RL) properties, four homes
   are substantially damaged, several properties are located in a "low to moderate

- Property will be acquired initially by the County of Lake and then transferred to local municipality, township or other local governments upon completion of the project.
- Emergency appropriations are needed for the total project cost of \$3,845,091, which is not included in the current year budget. SMC will use funding for project expenditures which will be reimbursed by the IDNR-OWR.
