WHEREAS, the parties to Intergovernmental Agreement 2011-55-016, acting by and through the Illinois Department of Healthcare And Family Services located at 201 South Grand Avenue East, Springfield, Illinois 62703 and Lake County State's Attorney located at 18 North County Street, Waukegan, Illinois 60085, desire to renew and amend the Agreement, and

WHEREAS, pursuant to Article 2.2 (Renewal), the Agreement may be renewed for additional periods; and

WHEREAS, pursuant to Article 7.1 (Amendments) the Agreement may be amended or modified by the mutual consent of the parties atany time during its term;

**NOW THEREFORE**, the Intergovernmental Agreement is renewed for the period July 1, 2012 through June 30, 2013 and is amended by deleting section 6.1 in its entirety and replacing it with the following:

**6.1 Amount of Payment.** The maximum amount of the Department's obligation under this Agreement is \$40,000.

All other terms and conditions shall remain in effect.
