Joint resolution authorizing the renewal of the State's Attorney's Multi-Jurisdictional Drug Prosecution grant (agreement #809123) awarded by the Illinois Criminal Justice Information Authority, including \$204,858 in federal ARRA 2009 JAG funds and covering the time period October 1, 2010 through September 30, 2011.

Member Calabresa reported on activities of Domestic Violence Council. Mr. Waller reported on the progress of the Family Visitation Exchange Center and advised that \$15,000 was needed to complete the center. Member Calabresa noted that fund raising activities were in progress to try to raise the money for completion of the project. Mr. Waller noted that the Cindy Bischof law which authorizes the use of GPS devices for offenders who have violated an order of protection is not totally live as yet. They are working on issues with the vendor; however the risk assessment portion of the new law is in use. Member Calabresa advised that there is another new committee being formed to look at Elder Abuse.

## 9. County Administrator's Report

### 9.1 10-0858

**Juror Compensation** 

Presented by Sr. Assistant County Administrator Amy McEwan. Ms. McEwan gave a brief history of juror compensation. Chief Judge Rosetti reported on juror services and how jurors are oriented and made to feel comfortable and the amenities currently provided to jurors. Mr. Zastany distributed a handout detailing the financial information on services provided to jurors and noted that they monitor their customer service standards and jurors are very happy. Mr. Zastany also reported that we pay \$45,000 to City of Waukegan for Juror parking. The Chief Judge and Mr. Zastany then took questions from the committee. Chair Nixon stated that she thought the City of Waukegan should have been present for the presentation.

#### 9.2 10-0849

Discussion of potential FY 2011 State Legislative Initiatives.

Sr. Assistant County Administrator Amy McEwan advised that we are still trying to fight HB 5055 - the bill that would allow the plaintiff to select the official who puts together the sale of the property. Ms. McEwan gave a brief history of the foreclosure process and judicial sales. Lt. Gregory reported on the 1 1/2 years that they have been performing the judicial sales and how the process works. Lt. Gregory advised that to date, there have been no contested sales. Member Carey asked that Lt. Gregory report on the benefits of having the Sheriff handle these sales rather than a private party. It was noted that one of the important aspects of having the Sheriff handle the process is that information can be obtained under FOIA. Discussion followed.
