Deputy County Administrator Hawkins gave a brief overview of the proposed change to the rules to include "or a Committee" to the Suspension of the Rules section (VI.F.3.d). There was no discussion.

#### 8.4 21-1216

Committee Action amending the County Board Rules of Order and Operational Procedures inserting a new title, IV.G, and paragraph IV.G.1: New Title IV.G: "Health and Safety of Meeting Attendees". New Paragraph IV.G.1: "The County Board seeks to provide an atmosphere of health, safety, and inclusion to treat everyone with courtesy and respect. Any and all health and safety rules that are in effect at the direction of the Administrator or the Board Chair for Lake County employees and the public entering County facilities shall also apply to all members of the Board, guests, and all public attending/while in attendance at meetings in County facilities."

Chair Frank gave an overview of the proposed rule change noting that it would make any employee rules pertaining to health and safety applicable to Board Members. Karen Fox, State's Attorney's Office, recommended deleting "attending/" from the proposed rule change for clarification purposes. Discussion ensued. A change was also made to clarify that the health and safety rules are in effect at the direction of the Administrator or the Administrator in consultation with the Board Chair.

A motion was made by Vice Chair Clark, seconded by Member Simpson, that this committee action item be approved as amended. The motion carried by the following vote:

#### 8.5 21-1217

Committee Action amending the County Board Rules of Order and Operational Procedures authorizing the Board Chair to allow electronic attendance for Executive Session for any meeting regardless of disaster declaration. Required amendments: (1) Delete, "excluding executive session" from paragraph VI.C.1 and (2) delete, "Executive (closed) Session requires Members to attend in person. In the event of a bona fide disaster as defined in Section VI.D of these Rules," from paragraph E.1.

Member Frank gave an overview of the proposed rule change regarding the Board Chair allowing for electronic attendance of Board Members for Executive Session. Discussion ensued.

A change was made so that the County Board Rules state that, "The Chair of the County Board may allow Executive Session participation by video means, based on the subject

matter of the specific Executive Session." A further change was made so that the Rules state that, "All Board Members attending Executive Session electronically must meet OMA requirements, as stated in section C.1. of the County Board Rules."

A motion was made by Member Wilke, seconded by Member Altenberg, that this committee action item be approved. The motion carried by the following vote:

Chair Frank gave an overview of the rule stating that when a physically present quorum is required to conduct a meeting, Board Members who have submitted a request to participate electronically will have their requests considered in the order in which they are received. There was no discussion.

Chair Frank gave an overview of the potential rule change, noting that reimbursement for Board Members using a personal cell phone in lieu of a County-issued device shall be \$35 per month, instead of \$56 per month. There was no discussion.
