# **PLANNING, BUILDING AND ZONING**

# **21. 12-0437**

Resolution adopting the multi-jurisdictional 2012 Lake County All Natural Hazards Mitigation Plan (ANHMP).

- The plan is required to be updated every five years by the Federal Emergency Management Agency to be eligible for FEMA hazard mitigation grant funds.
- The plan addresses natural hazards that may impact Lake County, such as floods, severe storms (e.g. wind, snow), tornadoes, and identifies mitigation measures that can be undertaken to reduce the impact of hazards to residents and the operational services provided.
- The plan update was developed through a cooperative effort between Lake County Emergency Management Agency, Lake County Stormwater Management Commission, and 46 municipalities.
- The ANHMP is one of several key components of Lake County's overall emergency management program. The County's EOP, County Department Emergency Plans, County Continuity of Operations Plan, County training and exercise program, and County ANHMP are integral parts of our overall preparedness and response effort.
- The cooperators group will meet on an annual basis to review plan objectives and identify program and projects goals.

#### FINANCIAL AND ADMINISTRATIVE COMMITTEE

# **22**. <u>12-0476</u>

Resolution authorizing a contract with Advocate Occupational Health to maintain vaccination and Personal Protection Equipment (PPE) fit testing records for employees in the amount of \$185,370.

- Currently, Advocate Occupational Health maintains vaccination and fit testing records for employees beginning with the pre-employment physical.
- Historically, the Health Department oversaw the program; however, it does not have the
  internal resources or record keeping ability to manage this process effectively and, as a
  result, this practice incurs liability to the County in the event of an adverse outcome.
- Transitioning of the entire program to Advocate Occupation Health will provide consistency of practice, continuity of records, and transfer the liability of these services away from the County.
- Pursuant to Article 6, Section 102, the Purchasing Agent convened an ad hoc review
  group that approved bid exemption on the basis of an existing long standing successful
  relationship for professional services, and the knowledge gained through this
  relationship adds value integral to the services provided.

# 23. 12-0448

Resolution authorizing a contract for Electricity Rate and Management Services in the annual estimated amount of \$1.7 million.

- Lake County desires to enter into a contract for Electricity Rate and Management Services.
- Invitations to Bid will be called for through the public bid process to determine the lowest kilowatt per hour for electricity for the County and due May 22, 2012.
- The commodity of electricity rates is a spot market commodity that requires contract execution within 24 hours of bids received.
- The contract authorizes the County Board Chairman to enter into a two-year agreement with three additional one year renewal options to determine a fixed rate per kilowatt hour to the lowest responsive and responsible bidder.

# 24. 12-0452

Resolution approving a County Board policy for "County Board Member Special Recognitions."

- Board members from time to time have requested County Board recognition for the achievements or accomplishments of an individual, business, school, or civic organization.
- These recognitions have historically been referred to as "resolutions" but have typically not been approved by the full County Board.
- This Resolution establishes criteria and a process for a County Board member to request a "County Board Member Special Recognition" that does not require full County Board approval.
- Under the proposed policy, a "County Board Member Special Recognition" will be drafted by Board staff, sent to the Communications staff for review, and signed by the Board member(s) initiating the request.
- This "County Board Special Recognition" process will be considered for incorporation of the "County Board Rules of Order and Operational Procedures" at the next meeting of the Rules Committee.

#### **25. 12-0486**

Resolution accepting the annual Emergency Management Assistance grant funding from the Illinois Emergency Management Agency for Federal Fiscal Year 2012 Emergency Management Performance Grant pass-through funds in the maximum amount of \$485,458.

- Lake County has applied for and been awarded an annual allocation from the Illinois Emergency Management Agency on behalf of the Lake County Emergency Management Agency.
- This funding supports the County in developing and maintaining an effective integrated Emergency Management Agency and program.
- This funding provides for quarterly reimbursement of up to 50% of allowable program costs for the Lake County Emergency Management Agency.
- The actual amount of funding is dependent on both the county's expenditures and the
  availability of federal funds to the Illinois Emergency Management Agency, which is
  dependent on the federal budget and FEMA grant program guidance.
- The maximum funding available to Lake County through this grant is \$485,458.
- This grant provides for Emergency Management program activities between October 1, 2011, and September 30, 2012.
- Revenue from this grant will offset currently budgeted expenses. No additional expenses are budgeted as a result of this grant.
- Lake County invests local funding in emergency management program activities to satisfy the grant match requirements.

# **26**. <u>12-0</u>445

Joint resolution authorizing a contract with The Comprehensive Group, a Health Pro Company, of Glenview, Illinois for physical and occupational therapy, as well as speech pathologist services in the estimated annual amount of \$744,000.

- Lake County desires to enter into a contract for physical and occupational therapy and speech pathologist services.
- Request for proposals were sent to 207 vendors with four firms submitting proposals.
- The Comprehensive Group, is recommended as the firm that best meets the needs of the rehabilitation residents at Winchester House.
- The resolution authorizes the Purchasing Agent to execute a two-year agreement with three additional one year renewal options for an estimated annual amount of \$744,000.
- The money spent on the contract is recouped through Medicare billing.

# **27**. <u>12-0489</u>

Joint resolution approving the Summer Youth Employment Worksite Agreement.

- Annually, the County approves a Summer Youth Employment Worksite Agreement with various organizations that will provide summer youth employment as part of the Lake County 2012 Summer Youth Employment Program.
- The Worksite Agreement outlines the responsibilities of the participating summer worksites and Lake County.
- This year, this agreement will be entered into with 30 to 35 organizations that will participate in this program.

 The joint resolution authorizes the County Board Chairman or their designee to sign the agreements.

# 28. 12-0491

Joint resolution authorizing various agreements for the Lake County Workforce Development Department's Youth Program Services.

- Lake County desires to enter into contracts for Youth Programs with qualified providers to service In-School and Out-of-School Youth under the federal Workforce Investment Act.
- Lake County extended Requests for Proposal to 194 providers and received 11 sealed proposals from seven service providers.
- The Workforce Development Board Selection Review Committee recommended, and the Workforce Investment Board approved, awards to six service providers that offered favorable proposals to meet the diverse needs of the student populations to be served.
- Contracts were approved for three In-School Youth Programs, including: North Chicago High School #187, Future First, North Chicago, IL in the amount of \$150,000 to service 22 youth, Zion Benton High School, Jobs For Bees, Zion, IL, in the amount of \$150,000 to service 21 youth and Waukegan High School, SHINE Educational Leadership Program, Waukegan, IL in the amount of \$150,000 to service 26 youth.
- Contracts were approved for five Out-of-School Youth Programs, including: North Chicago High School #187, CNA Program, North Chicago, IL in the amount of \$115,000 to service 15 youth, Waukegan High School, Pharmacy Tech Program, Waukegan, IL in the amount of \$150,000 to service 24 youth, Youth Build Lake County, North Chicago, IL for \$102,000 to service 12 youth, and First Institute Training and Management, Inc., Waukegan, IL, for \$160,000 to service 20 youth and Computer Systems Institute, Gurnee, IL in the amount of \$125,000 to serve 14 youth.
- In total, these contracts will cost the County \$1,102,000 and will be funded with the County's allocation of federal Workforce Investment Act funds.

#### **29. 12-0528**

Joint resolution approving a substantial amendment to the 2011 Annual Action Plan to incorporate new requirements for the Emergency Solutions Grant (ESG).

- The Homeless Emergency Assistance and Rapid Transition to Housing Act of 2009 (HEARTH Act) amended the McKinney-Vento Homeless Assistance Act resulting in the new ESG program.
- To implement the changes and in order to access new funds, HUD is requiring ESG recipient jurisdictions such as Lake County to complete a substantial amendment to its 2011 Action Plan.
- The substantial amendment consists of two primary parts: 1) Use of New ESG Funds;
   and 2) Written Standards for Provision of ESG Assistance.
- New ESG funds will be used for activities that are newly eligible under the HEARTH Act such as Homeless Management Information Systems and Homeless Prevention.
- Grantees for these activities will be selected at a later date through the standard Community Development Commission application process.
- Written standards for provision of ESG assistance were developed in consultation with the Lake County Coalition for the Homeless, and are designed to ensure consistency among all grantees for eligibility and service.

- The Community Development Commission recommended approval of the amendment at its April 25 meeting.
- This resolution authorizes the Chairman to execute all necessary documents to execute the amendment.

# 30. 12-0442

Joint resolution authorizing a contract with Radicom, Inc. of McHenry, Illinois for the purchase of radio equipment for the Lake County Sheriff's Office for up to \$137,952.

- Lake County extended requests to 31 vendors and three bids were received.
- Three bids received ranged from \$91,026 to \$153,032.58, one bid was considered non-responsive.
- Radicom, Inc. was the lowest most responsive and responsible bidder.
- This contract authorizes a purchase of 36 radios for up to \$137,952.

#### 31. 12-0518

Joint resolution authorizing a contract with HAIGES Machinery, Inc. of Huntley, Illinois for the emergency procurement of a replacement inmate property conveyor system in the amount of \$110,600.

- The inmate property conveyor is the system that provides inventory and storage for personal property of inmates housed in the Lake County Jail.
- The existing inmate property conveyor system has recently failed and it has been determined not to be economical to repair, due to age and present deteriorated condition.
- Pursuant to the Lake County Purchasing Ordinance emergency procurements are made when there is an existing threat to public health, welfare, or safety, or to prevent or minimize serious disruption of government services.
- Pursuant to Article 6, Section 103, the Facilities Manager submitted a written determination of the basis for the emergency and the certification that the selection of the contractor is appropriate.

#### **32. 12-0544**

Joint resolution authorizing an intergovernmental agreement with the Wildwood Park District for the purpose of providing Sheriff's marine patrol services.

 The Park District has agreed to continue the Marine Patrol Services contract for one more year during the months of May through September on the waterways of Gages Lake.  The contract continues an hourly rate of \$78 for the service of two Sheriff's Marine Patrol Unit officers and one boat to be schedule on weekday and weekend afternoons and evenings, according to the Park Districts needs.

#### 33. <u>12-0397</u>

Joint resolution authorizing an increase in the Death Certificate Surcharge as required by Public Act 97-0679.

- The current total cost to purchase certified copies of death and fetal death certificates is \$10.00 for the first copy and \$6.00 for each additional copy.
- The aforementioned charges include a fee of \$2.00 per copy issued that goes to the State of Illinois Death Certificate Surcharge Fund.
- As required by Public Act 97-0679, an additional \$2.00 fee is to be collected and deposited into the Cemetery Oversight Licensing and Disciplinary Fund, and results in additional State mandated fees totaling \$4.00 per copy.
- Effective July 1, 2012, the total fee for purchasing a certified copy of death or fetal death certificate will be \$12.00 for the first copy and \$8.00 for each additional copy.

# 34. <u>12-0471</u>

Joint resolution authorizing a professional services agreement with Crowe Horwath, Oak Brook, Illinois for Public Works revenue auditing professional services in the estimated amount of \$190,500.

- The Public Works Department desires to enter into an agreement with an accounting firm to perform revenue audits of the 19 wholesale municipal sewer accounts.
- Request for proposals (RFP) were sent to 32 vendors with nine firms submitting responses.
- A selection committee comprised of Public Works, Purchasing and Finance and Administrative Services recommended Crowe Horwath of Oak Brook, Illinois as the firm that best meets the needs of the County based on the RFP evaluation criteria.
- The resolution authorizes the Purchasing Agent to execute a two-year agreement with three additional one-year renewal options that will cost the County an estimated amount of \$190,500.

# 35. <u>12-0521</u>

Joint resolution authorizing a professional services agreement with AECOM Technical Services, Inc. of Sheboygan, Wisconsin for construction observation services for the Des Plaines River Water Reclamation Facility (WRF) phase IIA improvements project in the amount of \$715,978.

- The Des Plaines River WRF is a major wastewater treatment plant that provides services for the Villages of Long Grove, Lake Zurich, Kildeer, Buffalo Grove, Bannockburn, Riverwoods, Lincolnshire and unincorporated portions of southeast Lake County.
- Major equipment at the facility has reached the end of its useful life.
- This project includes replacement of two raw water pumps, two traveling bar screens, and installation of one 100-foot diameter clarifier, along with other miscellaneous building and equipment improvements.

- The County awarded this construction contract to Boller Construction Company, Inc. in the amount of \$4,688,000 and construction observation services are required from a professional engineering firm.
- The County determined that AECOM Technical Services, Inc. was the most qualified firm to provide professional engineering services for this project in accordance with the Local Government Professional Services Selection Act.
- This resolution authorizes the Purchasing Agent to execute an agreement for professional services with AECOM Technical Services, Inc. in the amount of \$715,978.

### **36.** <u>12-0543</u>

Joint resolution authorizing a professional services agreement with Clark Dietz, Inc. for engineering services related to the Vernon Hills Water Reclamation Facility (WRF) high efficiency blower installation and dissolved oxygen (D.O.) control project in the amount of \$60,550.

- The Vernon Hills WRF is a major wastewater treatment plant that provides services for the Villages of Vernon Hills, Mettawa, Indian Creek and unincorporated portions of Central Lake County.
- This project includes engineering services for replacement of one existing aeration blower with a new high efficiency blower and D.O. controls for the purpose of reducing electrical power costs.
- The County determined that Clark Deitz Inc. was the most qualified firm to provide professional engineering services for this project in accordance with the Local Government Professional Services Selection Act.
- This resolution authorizes the Purchasing Agent to execute an agreement for professional services with Clark Deitz Inc. of Kenosha, Wisconsin in the amount of \$60,550.

- Each year the LCDOT contracts for bituminous pavement, bituminous shoulders and bike path pavement maintenance throughout the County highway system.
- The seal coating of the LCDOT highway garage parking lot is included.
- The added alternative bidding process was used for this letting.
- A total of four bids were received, ranging from \$1,113,252.60 to \$1,555,613.55, and the lowest responsible bidder is J. A. Johnson Paving Company, Arlington Heights, Illinois, in the amount of \$1,113,252.60.

# 41. <u>12-0477</u>

Joint resolution appropriating \$5,901.96 of Motor Fuel Tax funds for Lake County's pro-rated share of the transportation planning undertaken by the Chicago Metropolitan Agency for Planning (CMAP), and designated as Section 13-00183-00-ES.

- CMAP, SFY 2013: Appropriation.
- CMAP staffs the Chicago region's federally required transportation Metropolitan Planning Organization (MPO).
- Federal funds for highway and transit projects, including the County's and the Lake County CMAP Council of Mayors, must be reviewed by the MPO.

- The County's pro-rated share for the period of July 1, 2012, through June 30, 2013, is \$5,901.96 for SFY 2013.
- Appropriation is from the Motor Fuel Tax fund.

# **42**. <u>12-0480</u>

Joint resolution authorizing a contract with Delcan Corporation, Schaumburg, Illinois, for professional services for the provision of traffic signal system enhancements for Lake County PASSAGE at a maximum cost of services described of \$1,998,789.54, appropriating \$2,400,000 of the ½% Sales Tax for Transportation and Public Safety funds, and designated as Section 12-00268-11-TL.

- <u>Lake County ITS PASSAGE</u>, Phase 4, <u>Design and Integration Services: Consultant</u> Agreement and Appropriation.
- The Phase 4 work for Lake County PASSAGE will enhance the current system, design and integrate field communication devices, maintain system components in the Traffic Management Center (TMC) and field, and adjust traffic signal timing.
- Lake County has a satisfactory working relationship with Delcan Corporation,
   Schaumburg, Illinois, under the Local Government Professional Services Selection Act.
- This resolution authorizes the execution of professional services agreement with Delcan Corporation for Phase 4 of Lake County PASSAGE design engineering services at a maximum cost of \$1,998,789.54.
- The appropriation of \$2,400,000 will come from the ½% Sales Tax for Transportation and Public Safety funds for this purpose.

#### 43. 12-0482

Joint resolution appropriating \$900,000 of ½% Sales Tax for Public Safety and Transportation funds for the replacement of the Traffic Management Center (TMC) PASSAGE video wall, including any associated construction, and designated as Section 12-00268-11-TL.

- TMC PASSAGE Video Wall Replacement: Appropriation.
- The TMC PASSAGE video wall display and associated servers are seven years old.
- The video wall display and server are failing and must be replaced.
- The existing video wall technology is out of date and requires an upgrade.
- The upgrade and replacement of the current video wall will require some construction work in the TMC.
- This work is in the 2012 program, and this resolution appropriates \$900,000 of ¼% Sales Tax for Public Safety and Transportation funds.

# 44. <u>12-0475</u>

Joint resolution authorizing a contract for the JULIE ticket screening and locating of Lake County Division of Transportation (LCDOT) storm sewers for excavator dig requests, for various County highways, to USIC Locating Services, Inc., Indianapolis, Indiana, in the amount of \$76,020 and designated as Section 12-00000-06-GM.

- FY2012 JULIE Locates Storm Sewer Services: Re-bid and Contract Award.
- Lake County Board, at its March 13, 2012 meeting, approved a contract award to USIC Locating Services, Inc., Indianapolis, Indiana, in the amount of \$50,880 as the lowest responsible and responsive bidder for the Julie ticket screening and locating.
- The USIC bid was later found to be non-responsive due to an exception limiting their

liability.

- This resolution adds to the schedule list a 4% fee to cover situations only involving administration costs, associated projects using Township MFT and/or general funds from the Townships or Road Districts.
- Illinois Department of Transportation (IDOT) approval is required.

- The Lake County Citizen Corps Council enhances the County's overall preparedness by facilitating information sharing, collaborative training and exercising, and providing educational materials.
- The Lake County Health Department and Lake County Emergency Management Agency have for several years utilized funding through this program.
- These grant funds from Federal Fiscal Year 2011 must be expended by December, 31, 2012.

# 58. <u>12-0439</u>

Resolution setting the compensation for certain County-wide elected office holders.

- Pursuant to State Statute, the County Board sets the compensation for elected officials no less than six months before those officials take office.
- At this time, it is necessary to set compensation for the Circuit Court Clerk, Coroner and Recorder of Deeds for the Fiscal Years 2013 through 2016.

#### **65. 12-0515**

Joint resolution authorizing the renewal of the State's Attorney's Juvenile Court Services Program Prosecution Support Grant, administered by the Illinois Criminal Justice Information Authority (ICJIA), with \$35,662 in federal funds for April 1, 2012 through March 31, 2013, and an emergency appropriation of \$7,712.

- This is a renewal of the Juvenile Court Services grant, formerly the Juvenile Accountability Incentive Block Grant, a federal Office of Juvenile Justice and Delinquency Prevention (OJJDP) grant administered through the Illinois Criminal Justice Information Authority (ICJIA). Funding for this grant began in 1999 and has been renewed each year. Federal funding for this program has been approved through 2013.
- The purpose of this grant program is to retain a sixth Assistant State's Attorney in the Juvenile Division to allow greater focus on violent juvenile offender prosecutions, and the reduction of overall case backlog.
- Program goals include: to continue funding support for 60% of one Assistant State's Attorney (ASA) position; to assign all violent crime cases, to a specific ASA for case handling from arraignment through sentencing; and, charge all serious and violent crimes within a reasonable time period.
- The emergency appropriation of \$7,712 is needed to accommodate the increase in award (\$6,940) and match (\$772) amounts, both of which will come from non-County sources.
- Sources of Program Funding include \$35,662 in federal funds, \$3,963 in matching funds provided from the State's Attorney's Asset Forfeiture Fund, and \$20,856 in County contribution as budgeted in the State's Attorney budget, for a grant program total of \$60,481.

# 66. <u>12-0450</u>

- Pursuant to Article 6, section 102, the Purchasing Agent convened an ad hoc review
  group that approved bid exemption on the basis of an existing long standing successful
  relationship for professional services, and the knowledge gained through this
  relationship adds value integral to the services provided.
- This resolution also authorizes an emergency appropriation of \$105,200 from the fund balance in the court automation budget.

#### 67. 12-0474

Joint resolution authorizing an emergency appropriation in the amount of \$45,000 in funding from the Illinois Department of Healthcare and Family Services and the approval of Grant Agreement No. 2012-55-024-K4D for the 19th Judicial Circuit's Access and Visitation Program for state fiscal year 2013.

- The 19th Judicial Circuit receives grant funding from the Illinois Department of Healthcare and Family Services to provide mediation services for never-married parents involved in visitation and custody-related disputes in an effort to increase child support collections from this population.
- The state would like to continue funding the 19th Judicial Circuit's program in the amount of \$45,000 for state fiscal year 2013.
- This access and visitation grant does not require matching funds.
- Last year, this program served 222 families.

- The Child Support Enforcement Division handles approximately 17,000 active cases, including those to establish paternity, to set support upon voluntary acknowledgement, to establish medical support orders, and to enforce orders for payment of support.
- IDHFS has tendered two proposed SFY 2012 contracts: one to reimburse 100% of personnel costs not to exceed \$772,226, 66% of which is federal funds, and one Federal Fund Participation (FFP) contract to reimburse 66% of administrative costs separate from personnel costs, up to \$40,000, which is 100% federal funds.
- Funding for the Lake County personnel costs contract, between the period of July 1, 2012 and June 30, 2013, is the same amount as State Fiscal Year 2011's contract.
   Funding for the FFP contract was decreased by \$60,000 from State Fiscal Year 2011.
