Joint resolution urging the Governor of Illinois and the General Assembly to work together to pass a transportation capital bill in Fiscal Year 2019 that will provide necessary sustainable funding to maintain the public infrastructure and make critical improvements to meet current and future travel demands, including engineering and constructing the improvements identified in the State Highway Consensus Plan for Lake County.

- Lake County is in support of a multi-modal transportation system that includes motorized and non-motorized elements.
- Lake County understands that an efficient and sustainable transportation network contributes to the high quality of life for County residents and promotes a strong economy.

- A State Highway Consensus Plan was developed in 2006 and reaffirmed with Lake County partner communities in 2019, which identified more than \$150,000,000,000 worth of regionally beneficial capacity improvements needed on the State Highway System.
- The Consensus Plan takes a regional approach and selected projects based on benefits to the overall system. Since 2006, this plan has been viewed as a model for collaboration, success, and results across the state.
- Lake County has invested more than \$150,000,000 of local money to improve the State Highway System over the past ten years, and more than \$1,000,000,000 worth of improvements remain on the State Highway Consensus Plan for Lake County.
