- The Board led the development of a resolution passed by the 21 partner public safety entities agreeing to participate in the development of an implementation and migration plan and commitment to contribute funds to hire a project manager and consultant services.
- Lake County has agreed to serve as the administrative agent for employing the
 project manager, entering into contracts, making payments, receiving dues or
 grants or other revenue, and for providing the financial accounting and reports as
 required.
- The Intergovernmental Agreement outlines the purpose of the Regional 9-1-1 Consolidation effort, the expected expenditure of the collected funds, and the timeline of the project.

Ordinance prohibiting the use of groundwater as a potable water supply by the installation or use of potable water supply wells or by any other method, related to an area in and around a closed landfill.

- A closed landfill exists on the site in question and ongoing remediation and testing have demonstrated that the groundwater in the area exceeds Illinois Class I standards for some parameters.
- The property owner is requesting that the County enact an ordinance to prohibit the use of groundwater from water wells as a potable source of water in designated areas around the closed landfill site in order to allow for development of these properties without further environmental remediation.
- The owner has secured similar ordinances from other neighboring jurisdictions.
- There are no current users of potable water wells in this designated area, and the Lake County Health Department has determined that new water wells would not be permitted in the area due to required setbacks to the closed landfill, and due to the proximity and availability of community (public) water in the area.
- The following County Departments have reviewed and concur with approval of the ordinance restricting use of potable groundwater in the designated area: Health, Planning, Building and Development, and Public Works.
- This item was approved at the August 13, 2019 County Board Meeting, but Exhibit A (attached) was inadvertently not included.

Joint resolution approving Modification Number Three for Agreement Number 14198 for the lease and management agreement between the County of Lake, Illinois, and Transitional Care of Lake County, LLC, (TCLC), Rosemont, Illinois, in the amount of \$175,000.

- In 2015 Lake County and TCLC entered into an Operations Transfer Agreement and a Lease and Management Agreement (collectively, the "Agreements") for the County's skilled nursing facility known as Winchester House in the amount not to exceed \$6,714,133.
- Two modifications in the amount of \$926,000 have been made to the original
 agreement that provided for an extension of the original terms for incentive
 payments, forgiveness of the start-up capital loan tied to construction milestones,
 and establishment of an Operational Support Fund.
- Modification Number Three increases the amount of the agreement in a not to exceed amount of \$175,000 to provide better beds and mattresses for the residents, once they have moved to the new facility.
- Modification Number Three shall be funded from the Winchester House Donation Fund, which contains money designated for improvements at the facility to better

service the residents of Winchester House. Funds have been previously used to pay for both services that benefitted residents, as well as capital items that improved the resident experience at Winchester House.

- TCLC presented this proposal to the Winchester House Advisory Board (WHAB), which voted to approve the request at the WHAB's meeting held on August 29, 2019.
- In accordance with Article 8, Section 101 (1) of the Lake County Purchasing Ordinance it is hereby requested that the County Board Chair be authorized to enter into Contract Modification Number Three; which increases the total cost of the agreement to \$7,815,133.

- Lake County Division of Transportation has a satisfactory relationship with Surveying and Mapping, LLC, Elk Grove Village, Illinois.
- Surveying and Mapping, LLC, Elk Grove Village, Illinois, has completed SUE and surveying services required for three separate projects to replace six culverts and one storm sewer.
- Project one in the amount of \$22,000 includes three culverts on Midlothian Road.
- Project two in the amount of \$17,865 includes three culverts on Gilmer Road, Old McHenry Road, and Monaville Road.
- Project three in the amount of \$17,700 includes a storm sewer on the Robert McClory Bike Path underpass at Wadsworth Road.
- These projects were individually funded from the Fiscal Year 2019 Miscellaneous Services appropriation approved by the County Board on October 9, 2018, and designated as Section 19-00000-02-EG.

Joint resolution appropriating \$100,000 of the ½% Sales Tax for Transportation funds for the acquisition of necessary right-of-way, by agreement or condemnation, and other right-of-way costs associated with the improvement of Fremont Center Road at Illinois Route 60.

- Fremont Center Road at Illinois Route 60 will be improved with the construction of turn lanes and a traffic signal.
- A previous right-of-way appropriation was approved by the County Board on January 17, 2017, for the advanced acquisition of a parcel. In that case, the property owner was planning on moving and had requested the County expedite the acquisition of the property due to the difficulty of selling it to someone who knows it would be acquired by the County later.
- This improvement is included in the Highway Improvement Program with targeted construction in 2020, and designated as Section 12-00138-02-CH.

Joint resolution authorizing a contract with Berger Excavating Contractors, Inc., Wauconda, Illinois, in the amount of \$128,234 for drainage improvements on Grass Lake Road, 350 feet west of Sibley Drive in Antioch, Illinois, and appropriating \$160,000 of County Bridge Tax funds.

- Storm sewer pipes and drainage structures on Grass Lake Road, 350 feet west of Sibley Drive in Antioch, Illinois, are at the end of their useful life and must be replaced or repaired.

Joint resolution authorizing an agreement with Robinson Engineering, Volo, Illinois, for engineering services for annual water tower and reservoir repair and rehabilitation.

 Lake County Public Works is seeking engineering services for annual water tower and reservoir repair/rehabilitation. This master agreement, sourced through a full statement of Interest (SOI) competitive process, will allow individual task orders to be issued up to a maximum cumulative value of \$85,000 for a given year. The term of the contract will be two years with three one-year renewal options to allow for future projects with services based on approved contracted rates.

- The Hawthorn Tower Rehabilitation/Refurbishment is identified as the initial project.
- The Lake County Purchasing received and evaluated Statements of Interest from 16 professional firms of which three were short-listed.
- In accordance with the Local Government Professional Services Selection Act, the recommended firm is Robinson Engineering, Volo, Illinois.
- The initial contract with Robinson Engineering will include condition assessment, design engineering and bidding assistance, construction administration assistance and observation based on contracted hourly rates in a total estimated amount of \$66,026.
- This service was included and budgeted as part of the Fiscal Year 2019 Capital Improvement Program.

Joint resolution authorizing a contract with Total Paving and Brick Services, Gurnee, Illinois, for the Asphalt Patching and Seal Coating Project in the amount of \$120,175, with renewal options.

- Public Works owns and operates water supply and sewer main systems, and sewage treatment facilities serving diverse communities throughout the County.
- Some facilities and underground systems are located under streets, paved driveways and parking areas which are in need of refurbishment.
- Some utility breaks occur under pavement and require pavement to be replaced.
- In accordance with the Lake County Purchasing Ordinance, bids were called for by publication for the Asphalt Patching and Seal Coating Project.
- Three sealed bids were received and publicly opened in the office of Lake County Public Works Department Administration Building on Tuesday, September 10, 2019 at 2:00 p.m.
- Total Paving and Brick Services of Gurnee, IL submitted the lowest responsive and responsible bid. Unit prices were provided as part of the bid.
- The term of the contract will be three years with two one-year renewal options to allow for future projects with services based on approved contracted unit prices. The future anticipated annual spend is estimated at \$250,000 annually.
- This resolution authorizes the execution of a contract with Total Paving and Brick Services in the amount of \$120,175. This project is included in Public Works Fiscal Year 2019 budget.

Resolution authorizing a Collective Bargaining Agreement (CBA) between International Union of Operating Engineers Local 150 and Lake County for skilled trades employees in the Division of Transportation.

- This is a three-year agreement beginning April 1, 2018 through March 31, 2021.
- Employees may perform work covered by other Local 150 CBA's under certain conditions.
- These employees will receive a 2.5 percent and 2.85 percent wage increase effective April 1, 2018 and April 1, 2019, respectively.
- Effective April 1, 2020 employees under this CBA shall receive the same general wage increase that non-union employees received on December 1, 2019.
- It is projected that the cost of general increase will be \$109,256 for Fiscal Year (FY) 2018 and \$127,666 for FY 2019.

- Construction Technology Laboratories, Inc. was awarded the initial contract in the amount of \$34,000 in accordance with the Local Government Professional Services Selection Act (50 ILCS 510/1 et seq) and a prior satisfactory relationship.

- Facilities has identified a need for Contract Modification Number One to increase the scope of work of the project to include Phase Two design, bid documents and bidding assistance in the amount of \$48,500.
- The additional scope of work includes additional hours needed to complete the development of concrete and asphalt repair and replacement construction documents, bidding and award recommendation for the project.

Ordinance amending Chapter 115, Video Gaming, of the Lake County Code of Ordinances.

- The Illinois Video Gaming Act, 230 ILCS 40, was recently amended to increase the number of video gaming terminals permitted for video gaming establishments.
- The Video Gaming Act allows establishments to have up to six video gaming machines.
- Lake County is amending Chapter 115, Section 115.04 C and D, of the Lake County Code of Ordinances to comply with state statute.

Joint resolution approving an agreement with Crowe LLP, Oak Brook, Illinois to provide consultant services supporting the procurement of a shared, scalable, integrated, enterprise family of public safety systems that includes computer aided dispatch (CAD), mobile data, records management systems (RMS) for law enforcement and fire / emergency medical services, and a jail management system (JMS) for the 9-1-1 Consolidation Implementation Planning Project in the amount of \$184,410.

- 21 public safety entities (PSE's) have agreed through an Intergovernmental Agreement (IGA) to participate in the 9-1-1 Consolidation Implementation Planning Project.
- The IGA between participating PSEs agrees to use Lake County as its
 administrative agent for entering into contracts, making payments, receiving dues
 or other revenue, and for providing financial accounting and reports.
- Participating PSEs have contributed to the 9-1-1 Consolidation Project Fund to cover project costs to include a project manager and 9-1-1 consultant services.
- The Board (through the IGA) has supported the establishment of a two-tier governance structure (governance committees) to serve as the decision-making body on behalf of all participating entities.
- The request for proposals were extended to 24 vendors. Sealed proposals were received from six vendors. Four vendors participated in the vendor interviews.
- Based on the criteria set forth in the request for proposals, an evaluation committee and the governance committees agree Crowe LLP to be in the best interest of

Lake County (on the Consortium's behalf).

• Funding is a combination of Consortium (\$80,000) and Lake County funds (\$104,410).

Joint resolution authorizing an emergency and temporary contract between Lake County, Lake County Sheriff's Office (LCSO) and the Special Education District of Lake County (SEDOL) for an additional School Resource Officer from September 16, 2019 to October 15, 2019.

- The LCSO has been providing SEDOL with a School Resource Officer at the Gages Lake Campus for over 15 years.
- SEDOL has made an emergency request for an additional School Resource Officer for 30 days, due to SEDOL staffing shortages.
- The SEDOL board held an emergency meeting authorizing funding for the additional School Resource Officer at the current hourly rate of \$99.50.
- LCSO drafted a temporary and emergency contract because a special detail contract would not suffice. Special detail contracts are voluntary and only certified School Resource Officers or Juvenile Officers can fulfil the requirements.
- The LCSO will remit the appropriate invoices for the hours worked for the months of September and October 2019.
- The LCSO anticipates staffing this emergency agreement with minimal, if any overtime.
- This agreement is for thirty (30) days and has a revenue estimate of \$16,000 over the term of the contract.

Joint resolution amending the Lake County Health Department Environmental Health Fees Schedule (as authorized in Lake County Code of Ordinances Chapter 178).

 The proposed revisions to the Environmental Health Fees Schedule would require licensed public swimming beaches to pay the same annual license fee as other seasonal swimming facilities (pools) pay.

- These public swimming beaches have been licensed by the Health Department since 2013 but have not been assessed an annual fee because the Department was receiving a federal grant that funded inspections and samples at beaches.
- Those federal funds have significantly diminished and no longer fund these
 mandated activities; therefore, the proposal is being made to require that the
 licensed beaches pay these costs.

Joint resolution authorizing an emergency appropriation with offsetting revenue in the amount of \$200,000 to support the goal of Lake County to end chronic homelessness.

- Since 2015, Lake County has participated in the "Built For Zero" technical
 assistance project for communities committed to ending homelessness. The lead
 Built for Zero entity, Community Solutions International, Inc., recently announced that
 Lake County Community Development was awarded \$200,000 in Built for Zero
 grant funding.
- In accepting these funds, Lake County commits best efforts to end chronic homelessness by December 31, 2019. The attached Grant Agreement states that "if for any reason Lake County does not meet this goal by the end of 2019, Lake County and its partners will continue working to end chronic homelessness until this goal is achieved." ("Ending homelessness" is defined in the homeless services sector and reaching "functional zero" level of homelessness in which all Lake County residents currently experiencing chronic homelessness are housed. After reaching "functional zero" communities can expect to continue to help homeless clients as they enter homelessness.)
- The new grant provides funding for an intern to manage the By-Name (waiting) List for permanent supportive housing, indirect costs and pass-thru grant funding for Catholic Charities to assist with housing the most difficult-to-house.
- This resolution authorizes an emergency appropriation of \$200,000 and the execution of a program agreement to accept the grant funding. The grant does not require a match.

- The intersection of Ela Road and Long Grove Road will be improved, inclusive of non-motorized improvements.

- A consulting firm will be utilized to perform these Phase II professional engineering services.

- LCDOT received and evaluated Statements of Interest and Qualifications, for Phase I and Phase II engineering services, from 36 professional firms of which four were short-listed and presented to a consultant selection committee.
- As a result of the interviews and successful Phase I completion, the selected and

recommended firm is STV, Inc., with a maximum cost of \$594,225.

 This project is included in the highway improvement program and targeted for construction in 2022, and designated as section number 14-00144-20-CH.

Resolution approving a Vendor Disclosure and Conflict of Interest Policy requiring vendors to submit a 'Vendor Disclosure Statement' for procurements over \$30,000.

- To ensure a transparent procurement process, vendors wishing to contract with Lake County for goods and services in an amount greater than \$30,000 shall be asked to disclose knowledge of familial relationships and political campaign contributions.
- To further ensure the integrity of the decision-making processes for county

procurements, all employees must disclose any conflict of interest that may directly or indirectly influence any procurement or ensuing agreement or contract.

- The County Board approved the initial version of this policy at its meeting on November 13, 2018 and it was further modified at the February 12, 2019 meeting.
- This revised policy applies to all Lake County employees and elected officials and any procurements or contract renewals effective February 1, 2019.
- Utility companies regulated by the Illinois Commerce Commission and local units of government are exempt from the requirement to disclose.
- Vendors other than utilities or local units of government requesting an exception will be required to submit their request in writing. Staff will contact the chair of the appropriate standing committee who will make the determination as to whether the procurement transaction will be included on the agenda.
- For all public procurements solicited by the Purchasing Division, staff will request a
 Purchasing Disclosure from any employee and/or consultant who is directly
 involved with the evaluation of bids or proposals received and signed Purchasing
 Disclosure forms must be on file prior to the release of related procurement
 information.

Ordinance amending Chapter 34: Taxation of the Lake County Code of Ordinances to establish a County Cannabis Retailers' Occupation Tax.

- On June 25, 2019, the Illinois Cannabis Regulation and Tax Act was signed into law, which will allow for the production, sale, and adult use of recreational cannabis.
- On August 9, 2019, a subsequent law was passed that effectuates Lake County's ability to collect a cannabis retailer's occupation tax.
- This ordinance, effective upon adoption, will allow for collection of cannabis retailer's occupation tax on recreational cannabis for incorporated and unincorporated areas on or after January 1, 2020.
- Absent any statutory amendments, the current law will delay collection of the tax until September 1, 2020.
